- (b) **Commission** means the Nagaland Public Service Commission.
- (c) **Committee** means the Departmental Promotion Committee.
- (d) **Department** means Finance Department.
- (e) **Departmental Training Institute** means the training institute under the Directorate of Treasuries and Accounts.
- (f) **Director** means Director (Treasuries and Accounts) of the Directorate of Treasuries and Accounts.
- (g) **Government** means the State Government of Nagaland.
- (h) **Governor** means the Governor of Nagaland.
- (i) **Grade** means a level or rank of post(s) in the Service which carry the same scale of pay.
- (j) **He** shall also mean she.
- (k) **Member of the service** means a person recruited into Nagaland Treasuries and Accounts Service both at the gazetted and non-gazetted level either before or after the commencement of these rules.
- (l) **Principal Director** means the Principal Director of Treasuries, Accounts and Audit.
- (m) **Secretary** means Additional Chief Secretary/Principal Secretary/Commissioner and Secretary/Secretary or whoever holds charge of the Department independently.
- (n) **Service** means the Nagaland Finance and Accounts Service and the Nagaland Treasuries and Accounts Subordinate Service.
- (o) **Schedule** means the Schedule appended to these rules.
- (p) **Scheduled Tribe** shall have the same meaning as in clause 25 of Article 366 of the Indian Constitution.
- (q) **Year** means Calendar year.

3. Composition of the service

The Service shall consist of:-

- (a) Persons, who, at the commencement of these rules are holding substantive posts specified in Schedule-I (A and B).
- (b) Persons recruited to the Service before the commencement of these rules.
- (c) Persons recruited to the Service in accordance with the provisions of these rules.

4. Classification/gradation of the service

The service shall consist of the following classes and grades of posts, namely:

(i) The Nagaland Finance and Accounts Service (Group – A)

- 1) Special Selection Grade : Principal Director
- 2) Senior Selection Grade : Director
- 3) Selection Grade : Additional Director
- 4) Higher Senior Grade : Joint Director
- 5) Senior Grade : Deputy Director/Senior Treasury Officer/ Senior Accounts Officer/ Senior Lecturer
- 6) Junior Grade : Assistant Director/ Treasury Officer/ Accounts Officer/ Lecturer.

(ii) The Nagaland Finance and Accounts Service (Group-B)

- 1) Sub-Treasury Officer/Junior Accounts Officer
- 2) Audit Officer
- 3) Divisional Accounts Officer

(iii) Nagaland Treasuries and Accounts Subordinate Service (Group-C)

- 1) Treasury Accountant/Auditor/Senior Divisional Accountant
- 2) Senior Accounts Assistant/ Assistant Auditor/Junior Divisional Accountant
- 3) Junior Accounts Assistant/Accounts Assistant

5. Strength of the service

- (1) The number of posts, permanent and temporary, under each grade shall be such as may be determined by the Government from time to time.
- (2) On the commencement of these rules, the strength of the service, permanent and temporary, shall be as shown in Schedule-I (A) and (B).

6. Method of recruitment

- (1) Recruitment to the Service shall be made by either of the following methods:-
 - (i) By Promotion of persons from lower grade.

- (a) Provided where promotion is to be made to the post of the Head of Department, the Administrative Head of the Department shall act as the Member Secretary and Head of Department shall not be included in the Committee.
- (b) The proceedings of the Committee shall be valid if attended by 03 (three) or more members, including one each from amongst serial number 1 and serial number 2, serial number 3 and serial number 4, serial number 5 and serial number 6.
- (2) All recruitment by promotion against posts outside the purview of the Commission shall be undertaken by a Departmental Promotion Committee consisting of the following:

8. Procedure for recruitment by promotion

- (1) Whenever any vacancies arises to be filled by promotion under Rule 6 (1) (i), against posts within the purview of the Commission, the Head of Department shall furnish the following, along with his comments, to the Government.
- The list of eligible candidates to be considered for promotion, containing at least thrice as many as the number of vacancies to be filled;
 - The final and undisputed Seniority List of the grade from which the promotion is to be given;
 - Dossiers of the officials concerned;
 - Year-wise breakup of the vacancies;
 - Annual Performance Assessment Appraisal Reports for the 05 (five) consecutive preceding years;
 - Vigilance Clearance;
 - Order of confirmation in service;
 - Integrity Certificates;
 - Service Rules; and
 - Any other documents considered relevant.

- (a) Upon receipt of the above list from the Head of Department, the Administrative Department shall furnish such particulars along with comments, if any, and other relevant documents as may be necessary, to the Commission.
 - (b) The Committee shall, when called upon by the Commission, meet and prepare a list of Officials equal to the number of vacancies, in order of preference, to be filled by promotion.
 - (c) The selection shall be based on merit-cum-seniority and in every case where a junior member of the Service is selected in preference to his senior in that Service, the Committee shall record in writing the reasons for such supersession.
 - (d) The select-list duly approved by the Committee shall be forwarded to the Administrative Department along with all the papers/documents received under sub-rule (i). Provided that in the event of any lapse in the conduct or performance of duties on the part of any of the persons in the select list, the Appointing Authority may, if it so thinks fit, remove such persons from the select-list in consultation with the Commission.
 - (e) The select-list shall be valid for a period of 01 (one) year from the date of its approval by the Committee and all vacancies arising in the Cadre during that period and intended to be accommodated by promotion shall be filled from the select-list only.
- (2) Whenever any vacancies arise to be filled by promotion under Rule 6 (1) (i), against posts falling outside the purview of the Commission, the Head of Department shall call upon the Committee to select from amongst the eligible members of the Service, indicating the number of vacancies to be filled by promotion and shall simultaneously furnish to the Committee the following:
- (i) The list of eligible candidates to be considered for promotion, containing at least thrice as many as the number of vacancies to be filled;
 - (ii) Final and undisputed Seniority List of the Cadre from which promotion is to be sanctioned;
 - (iii) Dossiers of the officials concerned;
 - (iv) Annual Performance Assessment Reports for the 05 (five) consecutive preceding years
 - (v) Vigilance Clearance;
 - (vi) Integrity Certificate;
 - (vii) Year-wise breakup of the vacancies;
 - (viii) Order of confirmation in service;
 - (ix) Service Rules;
 - (x) Any other documents considered relevant;
- (a) The Committee, then, shall prepare a select-list of officials equal to the number of vacancies, in order of preference, to be filled by promotion on the basis of merit-cum-seniority and in every case where a junior member of the Service is selected in preference to his senior in that Service, the Committee shall record in writing the reasons for such supersession.
 - (b) The select-list shall be valid for a period of 01 (one) year from the date of its approval by the Committee and all vacancies arising in the Cadre during that period and intended to be accommodated by promotion shall be filled from the select-list only.

9. Requirement for passing of departmental examination

- (1) Members of the Service appointed through direct recruitment from competitive examinations/interview or otherwise shall be required to pass a Departmental Examination prescribed in Rule 10(1) to be conducted on completion of the period of training and probation of 1 (one) year.
- (2) The members of service holding substantive posts at the time of commencement of these rules shall be required to undergo mid-career training course for 3 (three) months at the Departmental Training Institute and subsequently pass the departmental examination prescribed in Rule 10 (1). This shall be a one-time examination either at the Group A/ Group B level or at the Group C level. A member of the service who has passed one examination shall not be required to pass the other.
- (3) Sub-Rule (1) and (2) shall become effective from the date of notification of these rules.

10. Procedure for conduct of departmental examination

- (1) The Departmental Examination shall be conducted by the Departmental Training Institute from time to time covering the syllabus as given in Schedule-III (A) and (B).
- (2) A person shall be allowed a maximum of 3 (three) consecutive attempts to pass the departmental examination prescribed in Sub-Rule (1), failing which he shall be barred from further promotion.

11. Maintenance of select list for promotion

- (1) The Department shall maintain separate select lists for all categories of members, comprising of members who have passed the Departmental Examinations as per the provisions of Rules 9, 10 and 11.
- (2) If a member of the service passes the Departmental Examination within the three consecutive attempts permitted in terms of Rule 10 (2), his seniority in the lower grade shall be restored in the next higher grade.
- (3) A person may be removed by the Commission/Committee from the Select List for good and sufficient reasons to be recorded in writing.

12. Open competitive examination for direct recruitment

- (1) Whenever a vacancy arises, or is likely to arise within the next twelve months which is required to be filled by direct recruitment, the Appointing Authority shall send requisition to the Commission in terms of Schedule-II (A) and (B). The Commission shall thereafter advertise the post(s) specifying the terms and conditions of these Rules.
- (2) A written competitive examination followed by oral interview or both for the direct recruitment to the service shall be held at such time and place as may be prescribed in the notice issued by the Commission for the purpose. Every such notice shall, as far as possible, specify the number of vacancy/vacancies to be filled up.
- (3) A candidate must apply in such manner and in such form as the Commission may prescribe.
- (4) The Commission shall prepare a list of all candidates who have qualified in the examination in order of merit, which shall be determined in accordance with aggregate marks obtained by each candidate. In case two or more candidates obtain equal marks, the one who obtains higher marks in the written examination shall be ranked higher, and in case both the candidates secure the same marks in the written examination, the Commission shall arrange them in order of their relative dates of birth. The Commission shall forward the names in order of merit up to the number of vacancy/vacancies reported to them for direct recruitment. The list shall remain valid for a period of 6 months from the date of the Commission's letter of recommendation.

- (5) The inclusion of a candidate's name in the list shall confer no right to appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the service.
- (6) Reservation to the direct recruitment posts, including reservation of posts for Backward Tribes and Persons with Disabilities, shall be as notified by the Government from time to time.
- (7) For recruitment to the Subordinate Service (posts not falling within the purview of the Commission), the Department shall conduct the examination following the same procedure as mentioned in sub-rule (1) to (5), and in accordance with the rules and syllabus as may be prescribed by the Government from time to time.

13. Age limit for entry into the service

- (1) For a candidate for direct recruitment to the service, the minimum age shall be 21 years and the maximum age shall be 35 years as on the first day of the year in which the recruitment is held.
- (2) The upper age limit for SC/ST candidates shall be relaxable by 5 (five) years. For General Category candidates, the upper age limit shall be 30 years only. Further relaxation of age for serving government employees shall be allowed equal to the number of years they have served subject to a maximum of 5 (five) years.
- (3) The upper age limit for the physically handicapped persons shall be relaxed by another 5 (five) years.
- (4) The above Sub-Rules (1), (2) and (3) shall be subject to change as may be determined by the Government from time to time.

14. Academic qualification

A candidate for direct recruitment to the service must possess a Bachelor's Degree in any discipline from any recognized University.

15. Character

A candidate shall produce to the Commission/Appointing Authority certificates of good character either from -

- (i) The Principal/Academic Officer of the University or College or School in which he last studied.
- Or
- (ii) Two respectable persons (not related to the candidate) who are well acquainted with the candidate. Such a person shall be either an M.P. or an M.L.A. or a gazetted officer.

16. Physical fitness

A candidate should be of sound health, both mentally and physically, and be free from organic defects or bodily infirmity that are likely to interfere with his/her efficient performance of duties. A candidate shall be required to undergo a medical examination before such Medical Board or Medical Authority as may be prescribed by the Government.

17. Disqualification for appointment

- (1) No person shall be qualified for appointment to the service unless he is a citizen of India.
- (2) No person who has more than one spouse living shall be eligible for appointment to the service.

Provided that if a candidate is governed by any law recognized by the Government and if such person is allowed to have more than one spouse at a time by such law, and on production of a certificate to this effect by a First Class Magistrate/Competent Authority he shall not be disqualified by reason of that marriage:

Provided further that if any person, after joining the service under these Rules, marries again when the first spouse is still living and divorce or separation is yet to taken place, the person shall be immediately discharged from service, unless such person is governed by the proviso to this Rule.

- (3) Any person attempting to enlist support for his/her candidature directly by any recommendation either in written or oral or by any other means, shall be debarred from appointment to the service.
 - (i) A candidate, who is already in Government service or in the service of a statutory body, shall not be appointed unless a release certificate or a "No Objection Certificate" from the Government or the employer as the case may be, is furnished.
 - (ii) No person shall be appointed to the service, whose character and antecedents are adversely reported upon by a competent authority.

18. Appointment to the service from merit list

- (1) A candidate who is or has been declared by the Commission/Appointing Authority guilty of impersonation, submitting fake/fabricated documents, making statements which is incorrect or false, suppressing material information or of using or attempting to use unfair means in the examination/interview, of misbehavior in the examination/interview, in addition to rendering himself liable to criminal prosecution, shall be:-
 - (i) Debarred either permanently or for a specified period by the Commission/Appointing Authority from admission to any examination or appearance at any interview held by the Commission/Appointing Authority.
 - (ii) Liable to disciplinary action under the appropriate rules, if he is already in the service of the Government.
- (2) All appointments to the service shall be made by the Appointing Authority and no such appointment shall be made except through selection by either of the methods specified in Sub-Rule (1) of Rule 6.
- (3) A person shall join within 30 days from the date of issue of the order of appointment failing which, and unless the Appointing Authority extends the period, which shall not exceed two months, the appointment shall be treated as cancelled.
- (4) All appointments to the posts in the service shall be duly notified.

19. Probation

- (1) Persons appointed directly to the service through the Commission/Appointing Authority shall be on probation for a period of one year.
- (2) The Appointing Authority may, if it so thinks fit in any case or class of cases, extend the period of probation subject to a maximum period of two years.
- (3) The Appointing Authority may dispense with the services of those appointed on probation if during or at the end of the period of probation or extended period thereof, the person on probation is considered unfit for regular appointment, after giving him one month's notice in writing.

- (4) During the period of probation, a person shall be required to undergo such course(s) of training and instruction and to pass such Departmental Examinations as per the syllabus prescribed in Schedule-III (A) and (B).
- (5) The period of probation completed successfully shall count as qualifying service for all purposes.

20. Confirmation

A person on probation shall be eligible for confirmation provided:-

- (a) He has completed his period of probation to the satisfaction of the Appointing Authority.
- (b) He has undergone the prescribed training and has passed the Departmental Examination required under Rule 10.
- (c) He is considered fit otherwise for confirmation by the Appointing Authority.

21. Discipline and conduct

In the matters of discipline and conduct, the members of the service shall be subject to the provisions of the Nagaland Government Servants (Discipline and Appeal) Rules, 1967 and the Nagaland Government Servant (Conduct) Rules, 1968.

22. Scale of pay

The scale of pay admissible to members of the service in different grades shall be such as shown in Schedule-I (A) and (B), subject to such revision as may be made by the Government from time to time.

23. Fixation of initial pay

- (1) After the first appointment into service, the initial pay of a member of the service shall be fixed at the minimum of the time scale, unless under the provisions of Fundamental Rules and Subsidiary Rules or under any other Rules governing the fixation of pay for the time being in force, he is entitled to have his pay fixed at the higher stage in that time scale, or as per orders issued by the State Government from time to time.
- (2) On promotion of a member from a lower to higher category of post in the service, the initial pay shall be fixed in accordance with the principles governing such fixation under the Fundamental Rules for the time being in force.

24. Increment of pay

- (1) The first increment in respect of a member of the service appointed through direct recruitment shall accrue subject to passing of Departmental Examination conducted by the Departmental Training Institute after the probation period of 1 (one) year.
- (2) A member of the service on confirmation shall draw pay at the rate corresponding to his position in the time scale.

25. Seniority

Seniority in a cadre shall normally be determined with reference to the date of joining in that grade provided that:

- (i) The seniority of the promotees shall be determined in the order of preference/merit given by the Committee.
- (ii) Seniority of persons appointed through direct recruitment shall be determined in accordance with their position in the merit list.

- (iii) If appointments to the same grade of the service are made on the same year from the two sources of recruitment, the relative seniority between the promotees and the direct recruits shall be determined according to the rotation of vacancies between direct recruits and promotees based on the quotas for each source of recruitment, in accordance with the guidelines prescribed vide Home Department Apptt(A) Branch Memo No.11/AP/1/66 dated 9.6.1966.
- (iv) Each wing of post in Group B service as given in Rule 4 (ii) and each wing of Group C Service as given in Schedule II (B) shall maintain separate seniority lists. The different wings of the service shall merge into a single seniority at the level of Group A (Junior Grade) as given in Rule 4 (i).
- (v) Members of any lower grade shall have no claim for appointment to the higher grade except in accordance with the provisions of these Rules.

26. Posting

A member of the service shall be liable to be posted anywhere within the State or to any Department of the Government and in any capacity in his own grade, if so required, in the interest of public service.

27. Cadre review

The strength of the service and the number of posts included in the Service as specified at Schedule-I (A) and (B) may be reviewed by the Government as and when required after the commencement of these rules.

28. Reservation of post

There shall be reservation for the Backward Tribes of the State as well as for the physically handicapped against all categories of posts to be filled through direct recruitment, to the extent and in the manner laid down by the State Government from time to time:

Provided that in the case of reservation for Backward tribes, if no candidate is available from a particular backward tribe whose turn has come on the roster, the vacancy shall not be filled by a candidate belonging to any other tribe.

Provided further that if no candidate from a particular Backward Tribe is available for filling the vacancy earmarked for that backward tribe in the roster, such vacancy shall be treated as "*backlog vacancy*" and the process for filling such "*backlog vacancy*" shall be carried out as under:

- (i) The "*backlog vacancy*" shall be announced in the subsequent recruitments along with other vacancies (called the '*current vacancies*'); and
- (ii) The '*current vacancies*' shall be treated as one group and the '*backlog vacancies*' as a separate group and such '*backlog vacancies*', earmarked earlier for a particular Backward Tribe, shall be carried forward in the ensuing recruitments till the same are ultimately filled up by candidates from that particular Backward Tribe only.

29. Review of service:

An official's service, on attaining the age of 50 (fifty) years or 55 (fifty five) years, shall be reviewed as provided for under Fundamental Rule 56 (J).

30. Miscellaneous provision

All matters relating to pay, allowances, leave, pension, discipline and other conditions of service which are not specifically provided for in these Rules, shall be regulated by general rules framed by Government from time to time under Article 309 of the Constitution of India or continue to be in force under Article 372 *ibid* governing such matters.

31. Interpretation

If any question arises relating to the interpretation of these Rules, it shall be referred to the Government of Nagaland whose decision shall be final.

32. Repeal and savings

Any Rules corresponding to these Rules and immediately in force before the commencement of these rules, including the Nagaland Treasuries, Accounts and Audit Service Rules, 2002 (Part-I) and Amendments made thereto, hereby stands repealed.

Notwithstanding such repeal, any order made or action taken under any of the rules repealed, or under any general orders ancillary thereto, shall be deemed to have been validly made or taken under the corresponding provisions of these Rules.
