**LIQUEFIED PETROLEUM GAS (REGULATION, SALE AND DISTRIBUTION)
ORDER 2022**

Dated Kohima, the 01st June 2023.

No. SPLY/GEN/LPG/5/22/2017(Pt) : In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order of the Government of India in the Ministry of Petroleum and Natural Gas No. G.S.R -986(E) dated 8th November 1989 and Ministry of Industry & Civil Supplies (Department of Civil Supplies & Cooperation) Order No. S.O. 681 (E) dated 30th November 1974, the Governor of Nagaland is pleased to make the following Order namely:

1. Short title, extent, application and commencement:

- (i) This Order may be called the Nagaland Liquefied Petroleum Gas (Regulation, Supply, Sale and Distribution) Order 2022.
- (ii) It extends to the whole of the State of Nagaland.
- (iii) It shall come into force with effect from the date of publication of this Order in the Gazette of Nagaland.

2. Definitions:

In this order, unless the context otherwise requires:

- a) 'Business premises' means a place where the distributor normally stores and sells or distributes LPG to consumers.
- b) 'Consumer' means a person whose name is registered with a distributor for getting the supply of LPG filled cylinder from that distributor.
- c) Director "means the Director of Food & Civil Supplies, Nagaland or any other Officer authorized by the State Govt. to exercise the Powers of the Director under the provisions of this Order;
- d) 'Distributor' means a person including a firm, an association of persons, a company, a corporation or a co-operative society engaged in the said business of purchase, sale or storage for sale of LPG filled cylinder on the basis of an agreement with an Oil Company whether or not in conjunction with any other business and includes his representatives, employees, or commission agent but does not include in Oil Company.
- e) 'Form' means a form in the schedule to this Order.
- f) 'Government Oil Company' means any of the following oil industries manufacturing and marketing petroleum products.
 - i. Indian Oil Corporation Ltd.
 - ii. Hindustan Petroleum Corporation Ltd.
 - iii. Bharat Petroleum Ltd.
 - iv. Indo-Burma Petroleum Company Ltd.
 - v. Numaligarh Refinery Ltd.
 - vi. Oil and Natural Gas Corporation Ltd.
- g) 'LPG' means liquefied petroleum gas bottled in cylinder.
- h) 'State Government' means the Government of the State of Nagaland.

3. Regulation and sale of LPG:-

- (i) No distributor shall sell LPG at a price higher than that fixed by the Department.
- (ii) The Distributor shall maintain a daily stock account as per the proforma form-A annexed here under and display the daily stock position with its price at a conspicuous place of his business premises: -
 - (a) The opening stock of the day, filled, empty and defective cylinders;
 - (b) Quantity received during the day, filled empty and defective cylinders;
 - (c) Total quantity available on the day (that is opening stock and the quantity received);
 - (d) The quantity sold, delivered or otherwise disposed off during the day, filled, empty and defective cylinders;
 - (e) The closing stock of the day, filled, empty and defective cylinders;
 - (f) Such other particulars as the State Government may, by order in writing, specify from time to time;
- (iii) Every distributor shall maintain a register in which placing of demand for refill of LPG shall be recorded daily chronologically.
- (iv) Every distributor shall indicate at the business premises the working hours and shall not close premises during those working hours without the prior permission of the Regulating Authority.
- (v) Every Distributor shall have a godown for storage of LPG filled cylinders and shall obtain explosive license for storage of LPG in accordance with the laws and rules in force.
- (vi) The distributor shall take all reasonable steps to ensure that adequate stock of LPG is kept at his business premises at all times and shall not act in any manner prejudicial to the maintenance of supply and distribution of LPG to the registered consumers.
- (vii) The distributor shall keep with him the duplicate copy of the Consumers Registration Card, the original of which shall remain with the consumer. The Consumers Registration Card shall be in the form prescribed by the Oil Company.
- (viii) The distributor shall comply with the directions that may be given by the Regulating Authority or any other Officer of the Department not below the rank of Assistant Director of Supplies in regard to purchase, transport and sale of LPG, hours of sale or any other matter relating to LPG which they may deem proper to regulate the sale.
- (ix) The distributor shall submit the monthly returns of LPG as per the prescribed proforma in form 'A' to the Regulating Authority.
- (x) The distributor shall reserve 10% of the refills received in every consignment from the oil companies subject to minimum 50 (fifty) for distribution on the basis of premises to be issued by the Regulating Authority.
- (xi) The Distributor shall supply refill at the residences or at selected points of the consumers under home-delivery system. If the distributor cannot make home delivery or if the consumer does not opt for home-delivery, the distributor may give delivery of refill from his godown under 'ex-godown delivery system' provided that when a consumer takes ex-godown delivery, he should be given a rebate of such amount (being the component of transport charges included in the price of a refill) as may be declared by the Oil Companies from time to time which should be notified by the Regulating Authority.

4. Power of entry, search, seizure etc:-

- (i) The Director or any officer of the Food & Civil Supplies Department of the State not below the rank of Sub Inspector of Supplies or any officer authorized in this behalf by the State Government may with a view to security compliance with the provision of

this order inspect any place, book of accounts or other documents and where he has reason to believe that any of the provision of this order is contravened or about to be contravened break open or seal any place, premises, vehicle or vessel or any other conveyance used for carrying LPG cylinders and may authorize the taking of all measures for their custody.

- (ii) The provision of section 100 of the Code of Criminal Procedure, 1973 (2 of 1974) shall apply to search and seizure under this clause.

5. Power to grant exemption in special case:

If the State Government considers it necessary in public interest, may exempt any person or class of persons from the operation of all or any of the provisions of this order for such period and subject to such conditions (if any) as may be specified and may at any time suspend or cancel such exemption.

6. Appeal:

An appeal against any order of the Regulating Authority shall lie with the Commissioner & Secretary or Secretary of the Food and Civil Supplies Department of the State Government within 30 days of the date of the Order appealed against.

7. Penalty:

Any person contravening any of the provisions of this order shall be liable to punishment under Section 7 of the Essential Commodities Act, 1955.

**NAGALAND SUPERIOR KEROSENE OIL (LICENSING AND DISTRIBUTION)
CONTROL ORDER, 2022.**

Dated Kohima, the 01st June 2023.

No. SPLY/GEN/LPG/5/22/2017(Pt) : In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955, (10 of 1955) read with the Govt. of India in the Minister of Civil Supplies, (Department of Civil Supplies & cooperation) Order No. 681 (E) dated 30th November, the Governor of Nagaland makes the following Order, namely: -

1. Short title, extent and commencement:

- (a) This Order may be called the **Nagaland Superior Kerosene Oil (Licensing and Distribution) control Order, 2022.**
- (b) It shall extent to the whole of the State of Nagaland.
- (c) It shall come into force on the date of its publication in the Gazette.

2. Definitions: In this order unless the context otherwise requires: -

- a) "Dealer" means a person engaged in the business of purchase, sale or storage for sale of kerosene oil whether whole sale or retail and includes a hawker and an agent of an Oil Marketing Company (OMC) who has entered into an agreement with the Oil Marketing Company to distribute kerosene as whole-sale or retail dealer as the case may be but does not include an Oil Company.
- b) "Deputy Commissioner" means the Deputy Commissioner within their jurisdiction over the respective areas where the dealer carries on his business.
- c) "Director" means the Director of Food & Civil Supplies, Government of Nagaland and includes any other officer of the said department not below rank of Senior Inspector of Food & Supplies Civil Supplies Department authorized by the Government on this behalf to perform all or any of the functions of the Director under this order.
- d) "Form" means a 'Form' appended in the schedule to this order.
- e) "Hawker" means a person who carries kerosene from place to place for sale in retail not exceeding 5 litres per person at any one time.
- f) "Kerosene" shall have the meaning assigned to it in item No.7 of the first schedule to the Central Excise and salt Act, 1944 (1 of 1944) and shall not include Aviation Turbine Fuel.
- g) "Licensing Authority" means the Director of Civil Supplies, Govt. of Nagaland.
- h) "Retail dealer" means a person who sells kerosene in small quantities not exceeding 20 litres per person at any one time fixed by Government.
- i) "State Government" means the Government of Nagaland.
- j) "Whole sale dealer" means a dealer who sells kerosene to any other person for retailing or otherwise at whole sale rates in quantities of 20 litres or more at any one time.

3. Prohibition against carrying on business as a dealer without a license:

Every person carrying on business as a dealer shall possess a license under this order and abide by the terms and conditions of the license granted on this behalf by the licensing authority.

4. Application for license:

A person desires to obtain a license under this order shall make an application to the licensing authority in form 'I' and the licensing authority if satisfied may grant the license in form 'II'/III.

5. Form of license:

Licenses shall be issued to the whole sale dealer and the retailer under this order in form 'II' – (I) & form 'II' – (II) respectively and license issued to the Hawker be in Form 'III'.

6. Security Deposit:

Every person applying for license under this order, shall before the license is issued, deposit through D.D. drawn in favour of the licensing authority, a security as specified here under for the performance of the conditions subject to which the license, is granted.

(a) In case of Whole sale dealer :- Rs. 50000/-

(b) In case of retail dealer :- Rs. 10000/-

(c) In case of hawker :- Rs. 1000/-

7. Period of license and its renewal:

Every license granted under this order shall be valid for a period ending 31st day of March in the year in which it is issued and may be renewed for a period of one year with time.

8. Renewal of license:

Every license shall deposit their license for renewal within 30th day of April of the year following with a renewal fee of Rs. 500/- along with an application to the licensing authority. However, fine or late renewal of license is leviable at the rate of Rs. 100/- per calendar month or fraction thereof, if the license is not renewed within due date.

9. Fee for license:

(a) The fee payable for issue of a license or a duplicate copy of license in case of defaced, lost or destroyed or otherwise shall be Rs. 5000/- for Whole seller, Rs. 1000/- for Retailers and for renewal Rs. 1000/- for whole seller, Rs. 500/- for retailer and Rs. 100/- for Hawker.

(b) The fee payable shall have to be deposited in the form of Treasury Challan under the relevant head of Account.

10. Power to refuse license:

The licensing Authority after giving the dealer concerned an opportunity of stating the case in writing and for reason be to recorded in writing refuse to grant or renew a license.

11. Provision for cancellation or suspension of license:

If a dealer or agent, or servant on the dealer's behalf contravened any of the provisions of this order or any of the conditions of the license, than without prejudice to any other action, that may be taken against the dealer, the licensing authority may after giving him an opportunity for making his/her representation, by order suspend or cancel the license.

12. Forfeiture of security deposit:

(i) Without prejudice to the provisions of clause.

(ii) If the licensing authority is satisfied that the dealer has contravened any of the conditions of the license and forfeiture of the security is called for, may after giving the dealer a reasonable opportunity of being heard, by order forfeit the whole or any part of the security deposited by him and communicate a copy of the order to the dealer

(iii) If the amount of security at any time fall short of the amount specified in clause 6, the dealer forthwith shall deposit further security to make up the amount on being required by the licensing authority to do so.

- (iv) Upon due compliance by the dealer with all the conditions of the license, the amount of security or such part thereof which is not forfeited as aforesaid, shall be returned to the dealer after the termination of the license.

13. Maintenance of accounts:

Every licensee shall maintain correct and true accounts in respect of the business in such form and manner as the direction may specify.

14. Complying with orders and directions:

Every licensee to whom any order or direction is issued under any powers conferred by or under this order shall comply with such orders or directions.

15. Requisitions for sale of kerosene:

- (i) No. dealer shall sell kerosene at a price higher than the price fixed by the licensing authority.
- (ii) A dealer shall prominently display a stock-cum-price list at his business premises or near the entrance to the place of sales depot showing the opening balance of kerosene of the day and the selling price per litre.
- (iii) A dealer shall obtain an explosive license for storage of kerosene, if necessary, from the appropriate authority.
- (iv) A dealer shall display the working hours at a conspicuous place of the business premises. No dealer shall keep his sale depot/sub-depot closed during the working hours on any day without prior permission of the licensing authority.
- (v) A dealer shall take all steps to ensure that he has adequate stock of kerosene at his depot/sub-depot at all times.
- (vi) A dealer shall maintain true and correct accounts of purchase and sale of kerosene.
- (vii) A dealer shall comply with the directions that may be given by the licensing authority or any other officer of the Department not below the rank of Senior Inspector of Supplies in regard to purchase, transport, sale or storage of kerosene, hours of sale or any other matter relating to kerosene which they may think fit to regulate the sale.
- (viii) No dealer shall act in a manner prejudicial to the maintenance of supplies of kerosene in the state.
- (ix) The licensee shall give all facilities at all reasonable times to the licensing authority or any other officers of the Civil Supplies Department not below the rank of Sub-Inspector of Supplies, or any other officers or any person or a class of persons authorized by the licensing authority for inspection of the stock and accounts of kerosene and produce the license for inspection on demand.

16. Monthly returns by licensee:

Every licensee shall submit a monthly return of kerosene to the Licensing Authority as per prescribed form 'A' to reach the licensing authority on 1st day of every following month.

17. Power of entry, search, seizure etc:

- (i) The Director or any officer of Civil Supplies of the state not below the rank of sub-Inspector of Supplies or any officer authorized in this behalf by the State Government may with a view to secure compliance with the provision of this order, inspect any place, books of accounts or other documents and where he has reason to believe that any of the provision of this order contravened or about to contravene, break open or seal any place, premises, vehicle, or vessel and search, seize or remove any quantity of kerosene, books of accounts, vehicle, vessel or any

other conveyance used for carrying kerosene and may authorize the taking of all measures for their safe custody.

- (ii) The provision of section 100 of the code of Criminal Procedure, 1973 92 of 1974) shall apply to search and seizure under this clause.

18. Power to grant exemption in special case:

If the state Government considers it necessary or expedient in public interest so to do by order exempt any person or class of persons from the operation of all or any of the provisions of this order for such period and subject to such conditions (if any) as may be specified and may at any time suspend or cancel such exemption.

19. Appeal:

An appeal against any order of the licensing authority shall lie to the State Government within 30 days of the order appealed against.

20. Penalty:
