8. A Member may be terminated from the Advisory Council, if he/she is not able to contribute to the development of the Municipal/Town Council as per the report of the concerned Deputy Commissioner.
9. The Advisory Council Members shall not receive any remuneration or entitlements.
10. The person being considered for nomination should be a permanent resident of that particular Municipal/Town Council area.
11. Preference should be given to persons having knowledge in the fields of Law/ Planning/Business & Accounts/Social Services/Health/Civil Engineering/Water Supply/Solid Waste Management etc.

“ The other two members may be among persons whose requisite qualification is holder of at least a graduate degree in any discipline from a recognized University and such person may be appointed who are;

- (a) either serving or retired professor, or*
- (b) senior executive of financial institutions including bankers, or*
- (c) serving or retired Directors of reputed Higher Educational institutions, or*
- (d) eminent Advocate of Supreme Court of India or High Court, or*
- (e) a person who is well versed in public functions, eminent social/public worker with at least a graduate degree holder from a recognized University.*

4. **Amendment of Regulation 3 sub-clause (5)**

The entries under Regulation 3 sub-clause (5) shall be substituted with the following:

"A Search Committee consisting of the Chief Secretary as Chairman with four Officers in the level of Commissioner & Secretary and above shall make recommendations for selection of candidates as Members or Chairman of the Commission."

(b) against item 3, in column (3), for the word and letters “Audit, investigation, voluntary, SCN, annual return, reconciliation statement, others (specify)”, the words, letters, figures and brackets “Audit, inspection or investigation, voluntary, SCN, annual return, reconciliation statement, scrutiny, intimation of tax ascertained through **FORM GST DRC-01A**, Mismatch (Form GSTR-1 and Form GSTR-3B), Mismatch (Form GSTR-2B and Form GSTR-3B), others (specify)” shall be substituted;

(c) against item 5, in column (1), after the word and figures “within 30 days of its issue”, the words, letters, figures and brackets “, scrutiny, intimation of tax ascertained through Form GST DRC-01A, audit, inspection or investigation, others (specify)” shall be inserted;

(d) for the table, under serial number 7, for the table, the following table shall be substituted, namely:-
