Enhancement of Maternity Leave from 90 days to 180 days for the State Government female employees.

- The State Government of Nagaland is following the Central Civil Services (Leave) Rules, 1972 as amended from time to time. However, the changes in provisions relating to the Maternity Leave over the years have not been adopted for female State Government employees. Consequently, they are granted only 90 days maternity leave for two surviving children even as the Central Government has enhanced the Maternity Leave upto a period of 180 days.
- 2. Having reviewed the position, in the interest of public service, the Governor of Nagaland is pleased to enhance the existing ceiling of 90 days of Maternity Leave under CCS (Leave) Rules, 1972 to 180 days for the female State Government employees. The Maternity Leave will be applicable with the following conditions as per CCS (Leave) Rules, 1972:
 - A female government servant with less than two surviving children may be granted Maternity Leave by an authority competent to grant leave for a period of 180 days from the date of its commencement.
 - (ii) During such period, she shall be paid leave salary equal to the pay drawn immediately before proceeding on leave.
 - (iii) Maternity Leave not exceeding 45 days may also be granted to a female government servant (irrespective of the number of surviving children) during the entire service of that female government employee in case of miscarriage including abortion on production of medical certificate.
 - (iv)" Maternity Leave may be combined with leave of any other kind.
 - (v) Maternity Leave shall not be debited against the leave account.
 - (vi) A women employee in whose case the period of 90 days of Maternity Leave has not expired on the said date shall also be entitled to the Maternity Leave of 180 days.

Counting of Contract/Adhoc/Work-charged/Substitute period for retirement purpose.

- 1. The Nagaland Retirement from Public Employment Act, 1991, defines public employment as "appointment to any pensionable state public service or posts connected with the affairs of the State of Nagaland and the Nagaland Legislative Assembly, and includes any appointment under the Government of India, and other State Government, Central or State Public Sector Undertakings and local authority held by persons prior to their absorption under the public service of the State of Nagaland and the Nagaland Legislative Assembly which counts for the purpose of pension".
- And whereas, clarifications have been sought by Departments from time to time
 whether the services rendered in adhoc/contract/work-charged/substitute capacity prior to
 regular appointment made through NPSC or Departmental Selection Board or any other
 prescribed procedure shall count as public employment for the purpose of calculation of
 length of service under the above Act.
- 3. And whereas, in the judgment and order dated 24/07/2012, the Gauhan High Court in Case No. WA-168/2012, WA-175/2012, WA-177/2012, WA-178/2012, WA-179/2012, WA-180/2012, WA-181/2012, WA-183/2012, had ruled that the period of service rendered on adhoc/contract/work-charged has to be counted for computation of public employment under the Nagaland Retirement from Public Employment (2nd Amendment) Act, 2009.
- And whereas, this Department had issued office memorandum of even number dated 01.08.2012 regulating counting of past service as public employment for the purpose of pension under the Nagaland Retirement from Public Employment (2nd Amendment) Act, 2009.
- 5. And whereas, in a landmark judgement and order dated 14.03.2017 in W.A. No. 5(K) of 2017, the Kohima Bench of Gauhati High Court, referring to the judgement and order dated 14.06.2012 passed in WP(C) No.270(K) of 2011 and a batch of other writ petitions as well as the Order dated 20.07.2012 passed by the Division Bench in Writ Appeal No. 177/2012 alongwith a batch of other writ appeals, observed that "in view of the expressed provision defining public employment which does not distinguish between regular appointment and adhoc/contract/work-charged appointment for the purpose of retirement, period rendered on such basis has to be computed for the purpose of computation of 35 years of public employment". The High Court also held that "having come to the finding that the Memorandum dated 01.08.2012 is not in consonance with the judicial pronouncement of this Court, the Office memorandum dated 01.08.2012 is of no consequence and we declare the same to be a nullity in law".

- 6. Now, therefore, it has been decided that the period of service rendered on adhoc/contract/work-charged/substitute basis which is followed by regularization or regular appointment without break or any gap in service except resignation but notwithstanding the cases of resignations taken up with proper permission for another appointment, shall be treated as public employment and included in computation of length of service for the purpose of pension under the Nugaland Retirement from Public Employment (2nd Amendment) Act, 2009.

No. FIN/ESTT-2/11/VII CPC/16: The Governor of Nagaland is pleased to order as follows:-

- That the pay and pension of the employees of the Government of Nagaland shall be revised corresponding to the recommendations of the Seventh Central Pay Commission.
- 2. The revision of pay and pension shall come into force on the forenoon of 1st time 2017 for the purpose of notional pay lixation in the revised pay structure, and for the purpose of fixation of monthly pension in respect of the employees retiring from service on or after 1st June 2017. However, actual payments on the basis of the revised pay structure would be effective only from 1st January 2018. Accordingly, no arrears of salary or pension shall be payable for the period prior to 1st January 2018.
- Except for pensions and salaries of employees under the New Pension Scheme, the increased salary on account of revision of pay shall be impounded to the GPF accounts of the employees till 28th February 2020.
- 4. A Pay (Fitment) Committee shall be appointed by the State Government to examine the matter relating to revision of pay/pensions of the employees and to recommend fitment of their pay scales/pensions vis-a-vis the Seventh Central Pay recommendations.
- Subsequently, a detailed notification for the revised pay/pensions shall be issued after acceptance of the recommendations of the Pay (Fitment) Committee by the Stare Government.
- 6. After notional fixation of revised pay on 1° June 2017, a Government servant shall be entitled to annual increment (notionally) on 1° December 2017, subject to the condition that he/she has completed service of not less than six months on that date in the revised pay structure.

- The revised pay/pensions referred to above shall not be applicable to >
 - All categories of work-charged employees;
 - (ii) Persons paid out of contingencies;
 - (iii) Persons employed on contract, except where the contract provides otherwise;
 - (iv) Persons re-employed in Government service after retirement; and
- (v) Any other class or category of persons whom the Governor may, by order, specifically exclude from the operation of all or any of the recommendations made by the Pay (Fitment) Committee.
