Whereas, the Government of Nagaland has decided to set up the Register of Indigenous Inhabitants of Nagaland (RIIN), with an objective to prevent issuance of fake Indigenous Inhabitants Certificates, the following action needs to be taken in a time bound manner as per guidelines detailed below:

1. The Register of Indigenous Inhabitants of Nagaland (RIIN) will be the master list of all Indigenous Inhabitants of Nagaland.
2. This will be prepared with an extensive survey – with the help of village wise and ward wise list of Indigenous Inhabitants based on official records. This will be prepared under supervision of District Administration.
3. This list will be prepared in a period of 60 days with effect from 10th July, 2019 by designating teams for each village and ward (urban area) as below:
 - a) SDO (C) / EAC – Chairman
 - b) BDO / UDO – Member
 - c) Head Master of Govt High School – to be nominated by DEO - Member
 - d) 2 GBs nominated by the Deputy Commissioner - Member
 - e) 2 GPS/GMS/GHS teachers – nominated by DEO - Member
4. Deputy Commissioners will ensure that all teams are constituted by name within 7 days of publication of this notification and information about the teams is made public as also communicated to the Village Council Chairmen, VDB Secretary, Ward Authorities, Tribal Hohos, Church Authorities, NGOs and General public.
5. Adequate publicity about the Survey of Indigenous Inhabitants will be made at District level and State level by Home Department in association with DIPR.
6. The designated teams will go house to house and make a list of indigenous inhabitants actually resident in the household. Each family member will be listed in the village of their original residence and mention will be made if the concerned member is actually residing in town or Kohima or Dimapur or elsewhere. The format for making the list will mention Permanent Residence and Present Residence separately. Aadhaar numbers, wherever available will also be recorded.
7. The list of Indigenous Inhabitants will be published in the respective villages and wards and authenticated by Village and Ward Authorities under the supervision of District Administration. Each list will be signed by the concerned teams as also the Village and Ward Authorities.
8. The provisional lists prepared by the teams constituted as above will be published in the villages and the wards as also on the website of the District and the State Government on

11th September, 2019 and claims and objections can be filed for a period of 30 days i.e. on or before 10th October, 2019.

9. Anyone who thinks his name is missed out can submit a claim and anyone who thinks that someone's name has been wrongly included will be able to submit an objection.

10. The respective Deputy Commissioner will adjudicate on the claims and objections based on official records and evidence produced after giving an opportunity of being heard to the person filing the claim or the objection. For cases of objection, opportunity of being heard will also be given to the person to whose name objections have been made.

11. Proper orders will be passed by the Deputy Commissioners in each case which will be as per the existing laws and rules of the Government. This process will be completed in a period of 2 months i.e. on or before 10th December, 2019.

12. Based on this, the list of Indigenous Inhabitants will be finalized and each Indigenous Inhabitant will be given a Unique ID.

13. Accordingly, the final list of Indigenous Inhabitants, - the Register of Indigenous Inhabitants of Nagaland - RIIN will be created and copies of the same will be placed in the respective villages, wards, districts and at State level.

14. Electronic copies will also be placed in the Digital Locker at State Data Centre and a mechanism of electronic and SMS based authentication of Indigenous Inhabitant certificates will be built. This will be done as part of the Online System of Inner Line Permits.

15. All the Indigenous Inhabitants of Nagaland whose names are included in the RIIN will be issued barcoded and numbered Indigenous Inhabitant Certificates across the State.

16. Once the process is complete and all genuine Indigenous Inhabitants are issued certificates with Unique ID and Register of Indigenous Inhabitants of Nagaland is notified, all existing Indigenous Inhabitants Certificates issued by any authority will become invalid.

17. The entire exercise of the setting up of RIIN will be monitored by Commissioner, Nagaland to ensure time bound implementation of the Survey and finalization of the RIIN.

18. In addition, State Government, will designate Nodal Officers of the rank of Secretary to Government of Nagaland and above for each district who will monitor implementation of the entire plan of Survey and setting up the Guidelines. The nodal officers will be required to visit the districts allotted to them at least once per month. Their role will be monitoring the implementation and will not interfere in the adjudication process which will be solely the responsibility of the Deputy Commissioners. The Nodal Officers will submit monthly reports of their visits, meetings etc. to the Permanent Committee before 20th of each month.

19. The exercise will also be reviewed and monitored by the Chief Secretary every month.

20. Thereafter, no fresh Indigenous Inhabitant Certificates will be issued except for new born babies – children born to Indigenous Inhabitants of Nagaland – for whom it will be ensured to issue Indigenous Inhabitant Certificates along with the Birth Certificates and simultaneous

updating of the RIIN database with due intimation to the Village, Ward and District Authorities. This will be done as a feature to be incorporated in the Online System of ILPs which will have a component for RIIN also. The RIIN database will be updated with latest photographs and other details, every 5 years.

21. There will be a complete ban on issue of fresh Indigenous Inhabitants certificates and in case there is anyone who is left out from the RIIN, he/she will need to file an application before Home Commissioner who will get the matter verified and take necessary action for updating the RIIN if needed.

22. The Permanent Committee under Home Department will monitor the whole exercise of creation of RIIN and its implementation of the same.

23. Any Deputy Commissioner or any other officer or authority that issues any Indigenous Inhabitant Certificate in violation of these guidelines will attract disciplinary action.

All concerned are directed to comply with the above and complete the exercise of setting up of RIIN in a time bound manner.

3. The members of Village Disaster Management Authority (VDMA) should be permanent residents of the village.
4. The Village Disaster Management Authority (VDMA) shall comprise of at least 1 (one) woman member or more, depending on the composition of the Village Council.
5. The Village Disaster Management Authority (VDMA) may, as and when it considers necessary, constitute sub-committee from the existing key line committees in the village, such as Health, Power, Water & Sanitation and Education committees etc or any other sub-committee as necessitated.
6. The Village Disaster Management Authority (VDMA) shall coordinate and devise a working response mechanism with neighboring villages.
7. The Village Disaster Management Authority (VDMA) shall also coordinate with the sub-division authority and district authority on disaster management issues.
8. The term of the Village Disaster Management Authority (VDMA) shall be co-terminus with the term of the Village Council. In case of defunct Village Council, VDB Secretary shall be the officiating Chairman of the Village Disaster Management Authority (VDMA).
9. No remuneration shall be paid for the membership of Village Disaster Management Authority (VDMA) by the Nagaland State Disaster Management Authority/ District Disaster Management Authority.

Further in exercise of powers under Section 96 of the Motor Vehicles Act, 1988, the following rules are notified for regulation of Two Wheeler Taxis in the state:

(1). Rules and Guidelines for Two Wheeler Taxis in Nagaland:**I. Permit Conditions:**

1. The Regional Transport Authority of respective Districts shall be the permit issuing authority of Two Wheeler Taxis in the respective Districts.
2. The Two Wheeler to be registered as a Two Wheeler Taxi must be a brand new vehicle.
3. The permit issued shall be valid for a period of 5(five) years, which shall be renewable for another 5(five) years or the vehicle attaining 10 (ten) years from the date of purchase whichever is earlier, provided the vehicle pass the necessary fitness tests and Pollution Under Control conducted by an authorized inspector.
4. The vehicle to be registered as Two Wheeler Taxi must have a valid insurance cover for at least third party risk at all time as per the provisions of Section 146(1) of the Motor Vehicles Act, 1988.
5. The registration number shall be in black colour on yellow background/HSRP as per Rule 50(2)(d)(A) of the Central Motor Vehicles Rules, 1989.
6. The permit shall only be issued to bonafide unemployed indigenous inhabitants of the State.
7. The Regional Transport Authority of respective Districts shall limit the number of permits issued for each town in order to avoid overcrowding.
8. The permit shall not be transferable.

II. Other Conditions:

1. The Two Wheeler Taxi shall be allowed to ply only on the routes notified and allotted by the respective Regional Transport Authority within the Municipal/Town Limits of the Districts.

2. The rider of a Two Wheeler Taxi must possess a valid Driver's License to drive a two wheeler.
3. Both the Rider (Driver) and the Pillion shall wear helmet of specific standard provided by the Driver as per the provisions of Section 129 of the Motor Vehicles Act, 1988.
4. No rider shall carry more than one passenger as per Section 128(1) of the Motor Vehicles Act, 1988.
5. A male rider shall be allowed to carry both male and female passengers however a female rider shall be allowed to carry only female passengers.
6. The rider of the Two Wheeler Taxi shall not use Mobile Phone in any form while the vehicle is in motion.
7. The Taxi shall abide by the Traffic Rules at all times.
8. The Two Wheeler Taxi shall not be allowed to carry any luggage beyond the laden weight of the vehicle.
9. No modifications shall be made on the vehicle beyond the manufacturer's specifications besides the saddle bag for luggage (if necessary).
10. The routes shall be notified by the Regional Transport Authorities in their respective districts.
11. The fare shall be fixed by the respective Regional Transport Authorities of the Districts.
12. The Two Wheeler Taxi shall abide by :-
 - (a) All conditions under the Rent a Motor Cycle Scheme, 1997 under Section 75 of the Motor Vehicles Act, 1988.
 - (b) Any other Terms and Conditions/ Rules/ Guidelines issued by the Central or the State Government from time to time.

Besides the above conditions, all two wheeler Taxis shall be regulated in accordance to the provisions of the Motor Vehicles Act, 1988 and the Central Motor Vehicles Rules, 1989.

III. Conditions for suspension/cancellation:

The Registering and the Licensing Authority which granted the permit may cancel the permit or may suspend it for such period as it thinks fit as per the provisions of Section 86 of the Motor Vehicles Act, 1988 -

1. If any of the terms and conditions are violated.
2. If there is any misconduct or misbehavior towards the passengers/customers.
3. If any passenger/customer hailing a Two Wheeler Taxi files any complaint against the rider/owner and if the complaint is proved to be true.
4. If the vehicle is modified against the condition stated above or is ill maintained producing excessive noise from its silencer.
