O R D E R**Dated Kohima, the 13th Aug'2019**

NO.HOME/JL-1/99(Pt) :: Whereas in commemoration of the ensuing Anniversary of Independence Day 2019, the State Government has decided to remit the sentences against certain categories of prisoners who have been convicted by the courts (other than Court Martial) having criminal jurisdiction in the state of Nagaland and sentenced to rigorous imprisonment.

Now, therefore, in exercise of the power conferred by Sub-section 1 of Section 432 of the Code Criminal Procedure, 1973 (Act No. 2 of 1974 here-in after referred as the said Code) the Governor of Nagaland is pleased to grant remission of sentences to the different categories of prisoners as specified below, lodged in the jails of Nagaland and outside other than those in respect of whom the sentence is inflicted for an offence against the Order referred to in Sub-section 6 of Section 432 of the said Code passed under any law relating to which the Executive Powers of the Union extends.

The scale of remission of sentence for different categories is specified below:-

<u>CATEGORY</u>	<u>SCALE OF REMISSION</u>
1. Prisoners sentenced to 10 years and above	- 30 (Thirty) days
2. Prisoners sentenced to 5 years to 10 years	- 20 (Twenty) days
3. Prisoners sentenced to 1 year to 5 years	- 10 (Ten) days
4. Prisoners sentenced up to 1 year	- 5 (Five) days

Further, the aforesaid remission granted under the order shall not be admissible to the following categories of prisoners:-

1. Prisoners convicted under Foreigners Act
2. Prisoners convicted under Passport Act
3. Prisoners convicted under Unlawful Activities (Prevention) Act
4. Prisoners convicted under Section 3 to 10 of Official Secrets Act, 1923
5. Prisoners convicted under Section 2 to 3 of Criminal Amendment Act, 1961
6. Prisoners convicted under Section 121 to 130 of IPC

7. Prisoners convicted under Section 107/109 of CrPC
8. Prisoners convicted under Prevention of Corruption Act
9. Prisoners convicted of rape, attempt to rape or assault on women
10. Convicted prisoners found violating jail rules and discipline such as threatening/ intimidation/quarrelling/beating of fellow prisoners/staff and smuggling of contraband and prohibited articles
11. Foreign National convicted under any Acts.

In exercise of the powers conferred vide proviso to Article 309 of the Constitution of India, the Governor of Nagaland is pleased to make the following Rules regulating the recruitment and condition of Service of persons appointed to the Nagaland State Planning Machinery.

1. SHORT TITLE AND COMMENCEMENT:

- i These rules may be called "Nagaland Planning Machinery Service Rules, 2019"
- ii These shall come into force with immediate effect from the date of the publication of the notification.

2. DEFINITIONS:

In these rules, unless there is anything repugnant to the subject or context or constitution of India.

- a. "Appointing Authority" means the Governor of Nagaland in respect of Class I & II (Gazetted) posts and the Development Commissioner in respect of Class III (Non-Gazetted) posts.
- b. "Commission" means Nagaland Public Service Commission,
- c. "Committee" means the Departmental Promotional Committee
- d. "Constitution" means the Constitution of India,
- e. "Government" means the Government of Nagaland .
- f. "Governor" means the Governor of Nagaland.
- g. "Member" means a member of the Nagaland Planning Machinery Service appointed to the Service either before or after the commencement of these rules
- h. "Service" means the Nagaland Planning Machinery Service,
- i "Year" means the Calendar Year.
- j. "Degree of a Recognized University" means a degree of University incorporated by an Act of the Central or State Legislature in India, or other educational institutions established by an Act of Parliament, or declared to be a Deemed University under the UGC Act, 1956, or an equivalent qualification declared as such by an Order of the State Government.

3. CONSTITUTIONS AND CLASSIFICATION OF THE SERVICE:

- 1) The Service shall comprise of the classes of posts with pay scale as shown in Schedule - I. Provided that nothing in these rules shall affect the enabling power of the Government to add or reduce the number of such posts or to create new posts with different designations and scales of pay; whether permanent or temporary.
- 2) Persons substantially holding the posts scrutinized in schedule-I as on date of the notification of this service rule shall automatically become member of the service.

4. METHOD OF RECRUITMENT

1. Recruitment to the posts shall be made in the following manner, namely
 - (a) Direct recruitment
 - (b) By promotion
2. The sources of recruitment for each category of post, the percentage of posts reserved for each source of recruitment and the qualification required for direct recruitment will be as indicated in Schedule-II
5. Notwithstanding anything contained in Sub-rules above, if in the opinion of the Government, the exigencies of the service so required, the Government may, by order, after consulting the commission, if necessary, adopt any method of recruitment to the service other than those specified in the said Sub-rules.

6. AGE:

Minimum age recruitment to the Service shall be 21 years on the first day of the year in which recruitment is made. Maximum upper age limit shall be relaxable upto 30 years. The upper age limit shall be relaxable by another 5 years in respect of SC/ST Candidates and further, age concession of serving Government employees will be allowed the equal number of years they are in service subject to a maximum of 5 years.

7. RESERVATION:

Reservation of posts in the service for indigenous inhabitants of the State shall be in accordance with the Government policy in force. There shall be reservation for the backward Tribes of the State as well as for the physically handicapped against all categories of posts to be filled up through direct recruitment, to the extent and in the manner laid down by the State Government from time to time.

Provided that in the case of reservation for Backward Tribes, if no candidate is available from a particular backward tribe whose turn has come on the roster, the vacancy shall not be filled up by a candidate belonging to any other tribes.

Provided further that if no candidate from a particular Backward Tribe is available for filling up the vacancy for that backward tribe in the roster, such vacancy shall be treated as "backlog vacancy" and the process for filling such backlog vacancy shall be carried out as under:

- (i) The backlog vacancy shall be announced in the subsequent recruitment along with other vacancies (called the current vacancies);

- (ii) The 'current vacancies shall be treated as one. group and the 'backlog vacancies' as a separate group
- (iii) Such 'backlog vacancies', earmarked earlier for a particular Backward Tribe shall be carried forward in the ensuing recruitments till the same are ultimately filled up by candidates from that particular backward tribe only.

8. TRAINING:

Successful completion of induction, Professional and Mid Career Training on the subject of Planning, Implementation, Monitoring & Evaluation (PIME) and Project Management, sustainable Development concept will be mandatory for the 3(three) lower cadres PA, APO & PO for consideration of promotion to the next higher grade.

9. CONSTITUTION OF DEPARTMENTAL PROMOTION COMMITTEE:

1. All promotions under Rule 4 (I) (b) shall be done through a Departmental Promotion Committee consisting of the following members -
 - (a) Chairman, NPSC or Member of the NPSC nominated by the Chairman - Chairman
 - (b) One Member of the NPSC to be nominated by the Chairman - Member
 - (c) Chief Secretary, Nagaland or one Senior Officer not below the rank of Commissioner & Secretary to be Nominated by the Chief Secretary - Member
 - (d) Development Commissioner/Secretary, Planning - Member
 - (e) Addl. Dev. Commissioner, Planning & Co-ordination Department - Member Secretary
2. To enable the Commission to arrange for a meeting of the D P C., the Government should forward the following documents to the Commission.-
 - a. Prescribed DPC format duly filled with details
 - b. The final seniority list of eligible candidates from members of the cadre for which the promotion is to be considered the seniority list should contain at least twice the number of existing and possible vacancies in a year and should be submitted to the Commission.
 - c. Records of Services of the eligible candidates including Annual Confidential Reports for the last 5 Years.
 - d. Integrity Certificates in respect of eligible candidates with Vigilance clearance from Vigilance Commission, which should not be more than 6(six) months old.
 - e. Service Rules.
3. The committee shall prepare a list of eligible/ suitable candidates for promotion in order of merit -cum- seniority and forward the same to the Government. If in the process of selection, any member of the service is proposed to be superseded, the committee shall record the reasons thereof. Thereafter, the approval of the Appointing Authority to the recommended list shall be obtained. This select list will be valid for one year from the date of approval. All vacancies arising during that period and intents to be filled by the Departmental Promotion shall be filled from that list.

10. APPOINTMENT TO THE SERVICE:

- i. Direct recruitment to all the posts shall be made through competitive examinations to be conducted by the Nagaland Public Service Commission as per the procedure set out by the Commission from time to time.
- ii. The Commission after making selection as provided in Sub-rule (i) above, shall forward to the Appointing Authority the names and other details of candidates found suitable and recommended for appointment against the posts.
- iii. All appointment to the Services shall be made by the respective appointing authority and no such appointment shall be made except other selection by any one method specified under rule 4. All appointment related to gazette posts shall be published in the Gazette.
- iv. A person shall join within 30 days from the date of issue of order of appointment in case of direct recruitment failing which and unless the respective appointing authority extends the period, which shall not exceed 2 months, either the appointment shall be cancelled or the person shall lose his seniority under rule-12.

11. PROBATION:

- (1) Persons appointed directly to the service through the Commission shall be on probation for a period of 2 years: Provided that in respect of the persons who were appointed to the service on adhoc basis but subsequently regularised on the result of the competitive examination conducted by the Commission, the date of their joining in the service for the purpose of counting the period of probation shall be the date on which the result of examination was announced by the Commission
- (2) The Appointing Authority may, if it so considers fit, in any case or class of cases extend the period of probation.
- (3) The Appointing Authority may dispense with the services of a probationer if during or at the end of the period of probation or extended period thereof, the probationer is considered to be unfit for regular appointment.
- (4) During the period of probation, the person may be required to undergo such courses of training and instruction and to pass such examinations and tests as the competent authority may consider fit as condition of successful completion of the probationary period.
- (5) The period of probation completed successfully shall be counted in full as qualifying service for all purposes.

12. SENIORITY:

Seniority in a cadre shall normally be determined with reference to the date of joining in that cadre provided that:

- (a) The seniority of the promotes shall be determined as under Rule 9 in the order of the preference given by the Committee
- (b) Seniority of the persons appointed through competitive examination conducted by the Commission shall be determined in accordance with their position in the merit list provided that if a person did not join the service within one month from the date of issue of the offer of appointment or within the period of extension of joining time allowed, he will rank below those who joined before him.
- (c) If in a calendar year recruitment is made partly by the departmental promotion and partly by direct recruitment. The promotees will rank Senior to the direct recruits.
- (d) Persons already in service up to date of issue of this Notification shall be in accordance with the seniority list issued by the Department.

13. VERIFICATION OF ANTECEDENTS ETC:

- (1) The controlling authority shall make necessary inquiries as may be required so as to ascertain the suitability of any candidate in respect of nationality, age, character, antecedents etc and if as a result of such inquiries in the opinion of the controlling authority, the candidate is found to be unsuitable, such candidate shall be declared disqualified for appointment under intimation to the Commission.
- (2) No candidate shall be appointed to the Service who after such medical examination as the Government may prescribe is found suffering from such mental or physical deficiency as is likely to interfere in proper discharge of his/her duties.

14. CONFIRMATION:

Person appointed under Rule 10 Appointment to the Service shall be eligible for confirmation after he/she has put in three years of continuous service in the grade in which he/she is to be confirmed, provided that the following conditions are fulfilled:

- (i) He/she is considered fit for confirmation in consideration of all other aspects and condition as are or may be laid down by the Government.
- (ii) He/she has successfully completed the prescribed period of probation wherever necessary, and
- (iii) He/she has passed the Departmental Examination prescribed by the Government from time to time or successfully completed the course(s) of training(s)/instruction(s) etc.

15. RETIREMENT BEFORE SUPERANNUATION:

Review of officers and staff on attainment of fifty (50) years of age shall be done as stipulated in FR-56 (j) and the appropriate authority shall, if it is of the opinion that it is in the public interest so to do, the absolute right to retire any Officer or Staff by giving him/her notice of not less than three months in written or three months pay allowances in lieu of such notice.

16. MISCELLANEOUS:

Except as provided in these rules, all matters relating to pay, allowances, leave, pension, discipline and other conditions of service shall be regulated by general rules on this behalf framed under Article-309 of the constitution or other ordered in force on this behalf under Article-372 of the Constitution of India.

17. INTERPRETATION:

If any questions relating to interpretation of these rules arise, it shall be referred to the Government, whose decision thereon shall be final.

18. REPEAL AND SAVING:

- (1) All rules corresponding to these rules and in force immediately before the commencements of these rules are hereby repealed in respect of matters covered by these rules
- (2) Provided that any other order made or action taken under the rules so repealed shall be deemed to have been made or taken validity under corresponding provision of these rules
