**NO. GM-21/COAL-88/2014/266 ::** Whereas, the State Government is of the view that the Nagaland Coal Policy and Rules 2006 (First Amendment 2014) need to be implemented in strict compliance of the provision of the Rules for scientific assessment and extraction of coal in the State.

Whereas, the effective implementation of the Rules would regulate coal mining and facilitate the maintenance of the ecosystem, mitigate the impact on environment, control pollution, enhance economy and generation of revenue.

Whereas, it is deemed necessary to formulate Guidelines to strengthen and streamline the implementation of the provisions of Nagaland Coal Policy and Rules 2006 (First Amendment 2014).

Therefore, in the interest of public service and in pursuance of OM of Cabinet Meeting vide NO. CAB-2/2013(Pt) dated 6<sup>th</sup> February 2020, the Guidelines on implementation of the Nagaland Coal Policy and Rules 2006 (First Amendment 2014) is hereby notified and shall come into force with immediate effect.

**GUIDELINES ON IMPLEMENTATION OF THE NAGALAND COAL MINING  
POLICY AND RULES 2006 (FIRST AMENDMENT 2014).**

**1. Posting on attachment of District In-charge Officers to the Deputy Commissioner's Office:**

- a. The designated District In-charge Officer of the Coal bearing districts of Mon, Longleng, Tuensang, Mokokchung, Kohima, Wokha, Dimapur and Peren on posting shall also be placed on attachment to respective Deputy Commissioner's Office.
- b. In addition to the normal duties and responsibilities, the District In-charge Officers shall function under the purview of the respective District Planning and Development Board (DPDB).

**2. Prerogatives of stakeholding Departments and Agencies:**

The provisions of Rules 5, 6, 7 & 8 of NCMR 2006 (First Amendment 2014) provide the prerogatives of stakeholding Departments and Agencies.

- a. **District Administration:** The Non-encumbrance Certificate of scheduled mining lease area accorded by the District Administration may be further verified periodically and in the event of violation of terms of certification, the Non-encumbrance Certificate cancelled.
- b. **Pollution Control Board:** The pollution level of Air, Water and Solid Waste specified and Consented by the Nagaland Pollution Control Board may be further verified periodically and in the event of violation of the specifications, the Consent cancelled.
- c. **Environment, Forest and Climate Change Department:**
  - i). The Forest Clearance of scheduled mining lease area accorded by EF&CC Department may be further verified periodically and in the event of violation of certification, the Forest Clearance cancelled.
  - ii). In pursuance of Memo letter vide NO. FOR/GEN-57/2006 dated 4<sup>th</sup> Nov. 2011, a Green Cess @ Rs 30,000/- per hectare of scheduled mining lease area is levied and deposited with the EF & CC Department.  
On the closure of mine, it may be further ensured that the Environment Restoration Plan (ERP) prepared and prescribed by the authorized EF&CC Office is implemented.

**3. Delegation of Duties and Responsibilities:**

The provisions of Rule 3 to 22 of NCMR 2006 (First Amendment 2014) provide the aspects of Mining License, Maintenance of Coal Depot, Control and Monitoring of Mines and the delegation of duties and responsibilities.



**a. Mining License:**

- i). Application for Mining License addressed to the Director, Geology and Mining, through the District In-Charge Officer shall be initially made in plain paper and appended with land holding documentary proof of proposed mining area.
- ii). The District In-charge Officer shall verify the proposed mining area and determine the geographical coordinates and thereafter, forward the initial application along with verification Report and recommendations for issue of the prescribed Application Form.

**b. Maintenance of Coal Depot:**

- i). The District In-charge Officer shall verify, determine geographical coordinates and furnish feasibility Report of proposed Coal Depot site.
- ii). The District In-charge Officer shall coordinate to ensure that Coal is stocked in the designated Coal Depot and initiate necessary action on illegal stocking of Coal.
- iii). The District In-charge Officer shall periodically inspect, verify and report the maintenance of Coal Depot as per the provision of Rules.

**c. Control and Monitoring of Mines:**

- i). The District In-charge Officer shall make regular inspection of mining lease areas to ensure the maintenance and implementation of the Mining Plan and Mine Closure Plan and may co-opt the services of Departmental Mining Engineers/Geologists as and when required.
- ii). The District In-charge Officer shall initiate and coordinate with stakeholding Departments and Agencies for joint Mines Surveillance and mobile checking on illegal mining and transportation of coal.

**d. Regulation of Challan and Revenue Collection:**

- i). To maintain the credibility, accountability, security and prevent misuse of the Coal Transport Challan (CTC), the approved challan shall be printed in the designated Government printing press bearing distinct marking and series numbering assigned for each district.
- ii). The District In-charge Officer shall ensure the authenticity of weighment documents issued at the designated Coal Depot / Exit Gate and accordingly levy a Royalty at the minimum rate of 10 metric ton being the standard load capacity of a six wheeler truck against the Challan issued.  
In the event of transportation of Coal above the permissible load capacity, it shall be ensured that the prescribed penalty is levied against the Challan issued.



iii). The District In-charge Officer shall maintain the accounts of revenue realized against the Challan issued. Further, the Monthly Revenue Returns Statement (MRRS) and monthly account statement of used and unused Challan shall be furnished on or before the 5<sup>th</sup> of the following month.

**4. Departmental Sub-Committee:**

**NOTIFICATION**

**F.NO.FIN/REV-3/GST/1/08 (Pt-1)(Vol.1)/26** Dated Kohima, the 21<sup>st</sup> February, 2020.

In exercise of the powers conferred by sub-section (1) of section 9 and sub-section (5) of section 15 of the Nagaland Goods and Services Tax Act, 2017 (4 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Nagaland, Finance Department (Revenue Branch), F.NO.FIN/REV-3/GST/1/08 (Pt-1) "D" dated the 30<sup>th</sup> June, 2017, namely:-

In the said notification, -

- (a) in Schedule II - 6%, S. No. 242 and the entries relating thereto shall be omitted;
- (b) in Schedule IV - 14%, for S. No. 228 and the entries relating thereto, the following S. No. and the entries shall be substituted, namely: -

"228.	Any chapter	Lottery	14%"

12. It shall be mandatory for all Health Facilities to notify such person(s) to concerned District Surveillance Unit along with duly filled up self declaration forms, who, within their knowledge, are having travel history of COVID-19 affected countries as per the extant guidelines and are having complaints of fever or cough or respiratory difficulty or even without any sign and symptoms of COVID-19. In addition the history of coming in contact with suspected or confirmed cases of COVID - 19 shall be recorded.
  - i. In case the person has any such history in last 14 days and the person is symptomatic then the person must be kept in home/facility quarantine for 14 days from the day of exposure;
  - ii. In case the person has any such history in last 14 days and the person is symptomatic as per protocol and will be tested for COVID-19 as per protocol; and
  - iii. Information of all such cases should be given to Chief Medical Officer and Health Officer of the District immediately.
13. No person/institution/organization will use any print or electronic media for information regarding COVID-19 without prior permission of Health & Family Welfare Department, Nagaland. This is to avoid spread of any rumor or unauthenticated information regarding COVID-19. In case, any person/institution/organization is found indulging in such activity, it will be treated as a punishable offence under these regulations.
14. No private Laboratories have been authorized to take or test samples for COVID-19 in the State of Nagaland. All such samples will be collected as per guidelines of the Ministry of Health & Family Welfare, Government of India and these will be sent to designated labs by the State Nodal Officer appointed by the Health & Family Welfare Department, Nagaland.
15. Any person with a history of travel in last 14 days to a country or area from where COVID-19 has been reported must report to nearest Government Hospital or call a toll helpline number 7005415243/ 7005539653/ 9856071745, so that necessary measures/action if required may be intimated by Health & Family Welfare Department.
16. All person with a history of travel to a country or area from where COVID-19 has been reported in last 14 days, but who do not have any symptoms of cough, fever, difficulty in breathing, should isolate themselves at home and cover their mouth and nose with a mask. Such persons must take precautions to avoid contact with any persons including family members for 14 days from the date of arrival from such areas.
17. Authorized persons as per Clause 6 of these regulations are authorized under this Act to admit a person and isolate the person if required in case he/she has a history of visit to an area where COVID-19 is endemic and the concerned person is symptomatic.
18. If a suspected case of COVID-19 refuses admission or isolation, the officers in section 6 of these regulations will have powers to forcefully admit and isolate such case for a period of 14 days from the onset of symptoms or till the reports of Lab tests are received, or such period as may be necessary.

19. If cases of COVID-19 are reported from a defined geographic area such as village, town, ward, colony or settlement, the Deputy Commissioner of the concerned District shall have the right to implement following containment measures but not limited to these, in order to prevent the spread of the disease.
- i. Sealing of the geographical area;
  - ii. Barring entry and exit of population from the containment area;
  - iii. Closure of schools, offices and banning public gatherings;
  - iv. Banning vehicular movements in the area;
  - v. Initiating active and passive surveillance of COVID-19 cases;
  - vi. Hospital isolation of all suspected cases;
  - vii. Designating any Government/Building as containment unit for isolation of the cases;
  - viii. Staff of all Government departments will be at disposal of District Administration of the concerned area for discharging the duty of containment measures; and
  - ix. Any other measures as it think fit to control/prevent the epidemic directed by Department of Health & Family Welfare Nagaland.
20. District Disaster Management Committee headed by Deputy Commissioner is authorized for planning strategy regarding containment measure for COVID-19 in their respective Districts. The Deputy Commissioner may co-opt more officers from different departments for District Disaster Management Committee for this activity under these regulations.
21. **Penalty:-** Any person/institution/organization found violating any clause of these regulations shall be deemed to have committed an offence punishable under section 188 of Indian Penal Code 1860 (45 of 1860).
22. **Protection to person acting under Act:** No suit or legal proceedings shall lie against any person for anything done or intended to be done in good faith under the Epidemic Disease Act, 1897 (No. of 1897) unless proved otherwise.
23. These regulations shall come into force immediately and shall remain valid for a period of one year from the date of publication of this notification.

Person Liable for Registration under the Nagaland Goods and Service Tax Act, 2017

This circular is being issued for general information to all concern that the Nagaland Goods and Service Tax Act, 2017 has been implemented in the state of Nagaland since July 1, 2017;

The Nagaland Goods and Service Tax Act, 2017 stipulates that **every person** making a taxable supply of goods or services or both in the State shall be liable for registration of the business under the Act, if the aggregate turnover in a financial year exceeds 20 lakh rupees. (Refer Section 22 of the said Act)

Further, the Act also stipulates that **every person** making any inter-State taxable supply shall compulsorily be required to be registered under the Act irrespective of whether the aggregate turnover in a financial year exceeds 20 lakh rupees or not. (For details refer Section 24 of the Act).

Under Section 2 (84) the Act, person, inter alia, includes;

- (a) any corporation established by or under any Central Act, State Act or Provincial Act or a Government company as defined in clause (45) of section 2 of the Companies Act, 2013;
- (b) a co-operative society registered under any law relating to co-operative societies;
- (c) a local authority;
- (d) Central Government or a State Government;

It is, therefore, impressed upon all concerned to comply with the provisions of the Act. The District Tax Offices may be contacted for any assistance and support for GST compliance.
