Further to amend the Nagaland Goods and Services Tax Act, 2017 (Act No. 4 of 2017).

Be it enacted by the Legislature of Nagaland in the Seventy-first year of the Republic of India as follows :-

Short title and commencement. **1.** (1) This Act may be called the Nagaland Goods and Services Tax (Amendment) Act, 2020.

(2) It shall be deemed to have come into force with effect from the 31st March 2020.

Insertion of new section 168A in Nagaland Act 4 of 2017. **2.** After section 168 of the Nagaland Goods and Services Tax Act, 2017, the following section shall be inserted, namely:-

Power of Government to extend time limit in special circumstances. **‘168A.** (1) Notwithstanding anything contained in this Act, the Government may, on the recommendations of the Council, by notification, extend the time limit specified in, or prescribed or notified under, this Act in respect of actions which cannot be completed or complied with due to *force majeure*.

(2) The power to issue notification under sub-section (1) shall include the power to give retrospective effect to such notification from a date not earlier than the date of commencement of this Act.

Explanation.— For the purposes of this section, the expression "*force majeure*" means a case of war, epidemic, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature or otherwise affecting the implementation of any of the provisions of this Act.’.

1. In Rule 4, in sub-rule (1B), the existing clauses (i) and (ii) shall be replaced by the following namely:-

- “(i) A minimum turnover (MRP Value) of ₹ 3,000 crore per annum solely from lottery business of its own during the last three (3) years.
- (ii) The experience of having been a bonafide Distributor/Selling Agent of sound financial standing having sufficient experience of working in direct capacity as distributor/selling agent with any Organizing State during the last five (5) years.
- (iii) No distributor(s)/marketing agent(s) or their associate(s) having outstanding dues to a State Government in the form of sale proceeds on lottery, prize money, charges for draws, taxes, levies, GST, statutory dues etc. shall be allowed to participate in the bid.
- (iv) No Tenderer debarred or blacklisted by any Lottery Organizing State on account of violation of the provisions of the Lotteries (Regulation) Act or Rules shall be eligible to participate in the tender process.”

2. In the Annexure to the Lotteries (Regulation) Rules 2010, in Clause C, the following shall be substituted namely:-

- (i) In sub-clause (11), the words “90 days” shall be replaced by the words “30 days”.
- (ii) In sub-clause (13), the words “90 days” shall be replaced by the words “60 days”, and the words “60 days” shall be replaced by the words “30” days.

The above amendments shall come into effect from the date of their publication in the official gazette.
