- (i) in sub-rule (b), after the words "Commissioner of" and before the word "Taxes", the word "State" shall be inserted.
- (ii) sub-rule (f) shall be omitted.

**3. Amendment of rule 3**

In rule 3 of the principal rules, for sub-rules (a) to (c) the following sub-rule shall be substituted: namely,-

**"(a) The Nagaland Taxation Service-Grade A (Gazetted)**

The members of this class shall be called Special Commissioner of State Taxes, Additional Commissioner of State Taxes, Joint Commissioner of State Taxes, Deputy Commissioner of State Taxes, Assistant Commissioner of State Taxes, and shall constitute a grade. They shall belong to Grade A (Gazetted) Service.

**(b) The Nagaland Taxation Service- Grade B (Gazetted)**

The members of this class shall be called the Commercial State Tax Officer and shall constitute a grade. They shall belong to Grade B (Gazetted) Service.

**4. Amendment of rule 5**

In rule 5 of the principal rules, in sub-rule (b), after the words "of the gazetted posts" and before the words "that are to be filled", the words " and cent per cent of the non-gazetted post" shall be omitted.



**5. Amendment of rule 6**

In rule 6 of the principal rules, for sub-rules (a) to (c), the following sub-rules shall be substituted: namely,-

**"(a) The Nagaland Taxation Service Grade A.**

- (i) All vacancies of Special Commissioner of State Taxes shall be filled up by promotion from amongst the confirmed members of Taxation officers who have put in 02 (two) years of regular service in the grade of Additional Commissioner of State Taxes.
- (ii) All vacancies of Additional Commissioner of State Taxes shall be filled up by promotion from amongst the confirmed members of Taxation officers who have put in 03 (three) years of regular service in the grade of Joint Commissioner of State Taxes.
- (iii) All vacancies of Joint Commissioner of State Taxes shall be filled up by promotion from amongst the confirmed members of Taxation officers who have put in 04(four) years of regular service in the grade of Deputy Commissioner of State Taxes.
- (iv) All vacancies of Deputy Commissioner of State Taxes shall be filled up by promotion from amongst the confirmed members of Taxation officers who have put in 05(five) years of regular service in the grade of Assistant Commissioner of State Taxes.
- (v) All vacancies of Assistant Commissioner of State Taxes shall be filled up by promotion from amongst the confirmed members of the Taxation officers who have put in 07(seven) years of regular service in the grade of Commercial State Tax Officer.

**(b) The Nagaland Taxation Service Grade B.**

All vacancies in the post of Commercial State Tax Officer shall be filled up by direct recruitment in accordance with the provisions laid down under Rule 8".

**6. Amendment of rule 7**

In rule 7 of the principal rules,

- (i) For the heading, the words "Selection of Promotion" the words "Selection for Promotion" shall be substituted.
- (ii) In sub- rule(c), after the words "to the post of" and before the words "shall be given", for the words "Inspector of Taxes", the words "Commercial State Tax Officer" shall be substituted.
- (iii) After sub-rule (c), the following sub-rules shall be inserted: namely,-
  - (d) The Government or the Commissioner, as the case may be, shall prepare a list of officers eligible for promotion, in any case not exceeding three times the number of the vacancies in the order of seniority and shall forward the same to the Commission together with such other documents

as may be relevant for the purpose of making selection by the Commission constituted for the purpose.

(e) The Commission shall consider the list along with other documents received from the Government or the Commissioner, as the case may be, and shall forward to the Government or the Commissioner, as the case may be, after such examination as may be deemed necessary, a list of name in the order of preference.

#### **7. Amendment of rule 8**

After sub-rule (b), the following sub-rules shall be inserted: namely,

- (c) A waiting list, not exceeding 25% of the vacancies advertised shall be maintained by the Commission in respect of the examination conducted by them. The waiting list shall remain valid for 6 (six) months from the date the results are declared by the Commission.
- (d) The name from the waiting list shall be requisitioned by the Government (concerned Department) only if a candidate recommended by the Commission.
  - (i) does not join the post after an offer has been made to him/her by the Government, or
  - (ii) has been found medically unfit, or
  - (iii) has been declared unsuitable for appointment on verification of character and antecedents, or
  - (iv) resign after joining the post before the expiry of 6 (six) months from the declaration of result by the Commission.
  - (v) The waiting list shall operate only within the posts advertised by the Commission, and the waiting list will not be used for filling up an additional vacancy reported by the Government after the last date of receiving application as mentioned in the advertisement issued by the Commission.
  - (vi) The inclusion of a candidate's name in the list of successful candidates shall confer no right to him for appointment, unless the Government is satisfied after such enquiry as may be considered necessary, that the candidate is suitable in all respect for appointment to the service.

#### **8. Amendment of rule 9**

In rule 9 of the principal rules,

- (i) For sub-rules (a) & (b) the following sub-rules shall be substituted: namely,-
  - (a) The age of a candidate for direct recruitment to the service under rule 5 (a) (ii) shall not be less than 21 years and not more than 35 years as on the first day of January of the year in which the recruitment is held. For general candidates, the upper age limit will be 30 years. Further, age concession for serving Government employee will be allowed, equal to the number of years they are in service subject to a maximum of 5 years.
  - (b) The upper age limit for Physically Handicapped will be relaxed by another 10 (ten) years.

- (ii) In sub-rule 2, after the word "the" and before the word "minimum", the word "Principal" shall be omitted.

**9. Amendment of rule 11**

In rule 11 of the principal rules, sub – rule (d) shall be omitted.

**10. Amendment of rule 13**

In rule 13 of the principal rules,

- (i) Before the sub-rule (a) and sub-rule (b), the symbols and figures "(i)" and "(ii)" respectively shall be omitted.
- (ii) In sub-rule (b), after the words "Departmental Examination" the words "and undergo such trainings as the Government or the Commissioner may, as the case may be, from time to time prescribe" shall be inserted.

**11. Amendment of rule 17**

In rule 17 of the principal rules,

- (i) In sub-rule (a),  
 (a) after the words "the scale of pay" and before the words "be as shown", the word "shall" shall be inserted.  
 (b) after the word "Schedule", for the figure "II", the figure "I" shall be substituted.
- (ii) In sub rule (c), the word "quality" shall be substituted with "qualify".

**Nagaland Goods and Services Tax (Eight Amendment) Ordinance, 2023**

(Nagaland Ordinance No. 6 of 2023)

Promulgated by the Governor of Nagaland in the Seventy-Fourth year of the Republic of India

Ordinance**

further to amend the Nagaland Goods and Services Tax, Act 2017 (Act No. 4 of 2017) to incorporate the amendments made to the CGST Act, 2017 to bring uniformity in the application of the CGST and SGST Acts.

Whereas, the Legislative Assembly of the State of Nagaland is not in Session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

Now, therefore, in exercise of the power conferred by clause (1) of Article 213 of the Constitution of India, the Governor of Nagaland is pleased to promulgate the following Ordinance, namely:-

Short title and  
commencement

1. (a) This Ordinance may be called the Nagaland Goods and Services Tax (Eight Amendment) Ordinance, 2023.
- (b) It shall extend to the whole of Nagaland.
- (c) It shall come into force on such date as the State Government may, by notification appoint.

Provided that different dates may be appointed for different provisions of this Ordinance and any reference in any such provision to the commencement of this Ordinance shall be construed as a reference to the coming into force of that provision.

Amendment  
of section 2.

2. In section 2 of the Nagaland Goods and Services Tax Act, 2017 (hereinafter referred to as the principal Act),—

- i. after clause (80), the following clauses shall be inserted, namely:—

'(80A) "online gaming" means offering of a game on the internet or an electronic network and includes online money gaming;

(80B) "online money gaming" means online gaming in which players pay or deposit money or money's worth, including virtual digital assets, in the expectation of winning money or money's worth, including virtual digital assets, in any event including game, scheme, competition or any other activity or process, whether or not its outcome or performance is based on skill, chance or both and whether the same is permissible or otherwise under any other law for the time being in force;';
- ii. after clause (102), the following clause shall be inserted, namely:— '(102A) "specified actionable claim" means the actionable claim involved in or by way of—
  - i. betting;
  - ii. casinos;
  - iii. gambling;
  - iv. horse racing;
  - v. lottery; or
  - vi. online money gaming;';
- iii. in clause (105), the following proviso shall be inserted at the end, namely:—

"Provided that a person who organises or arranges, directly or indirectly, supply of specified actionable claims, including a person who owns, operates or manages digital or electronic platform for such supply, shall be deemed to be a supplier of such actionable claims, whether such actionable claims are supplied by him or through him and whether consideration in money or money's worth, including virtual digital assets, for supply of such actionable claims is paid or conveyed to him or through him or placed at his disposal in any manner, and all the provisions of this Ordinance shall apply to such supplier of specified actionable claims, as if he is the supplier liable to pay the tax in relation to the

- supply of such actionable claims;";
- iv. after clause (117), the following clause shall be inserted, namely:— "(117A) "virtual digital asset" shall have the same meaning as assigned to it in clause (47A) of section 2 of the Income-tax Act, 1961 ;".
- Amendment of section 24.
3. In section 24 of the principal Act,—
- i. in clause (xi), the word "and" occurring at the end, shall be omitted;
- ii. after clause (xi), the following clause shall be inserted, namely:—
- "(xia) every person supplying online money gaming from a place outside India to a person in India; and".
- Amendment of Schedule III.  
Transitory provision.
4. In the principal Act, in Schedule III, in paragraph 6, for the words "lottery, betting and gambling" the words "specified actionable claims" shall be substituted.
5. The amendments made under this Ordinance shall be without prejudice to provisions of any other law for the time being in force, providing for prohibiting, restricting or regulating betting, casino, gambling, horse racing, lottery or online gaming.
