No.EMP-2/96/2015/156 :: In order to govern the operations of private placement agencies (PPAs) offering placement services for private sector jobs within India, the Governor of Nagaland is pleased to notify the regulatory framework with effect from the date of publication of this Notification in the Nagaland Gazette.

**Regulatory Framework for Private Placement Agencies Operating in
Nagaland**

1. Introduction

This regulatory framework, established by the Department of Employment, Skill Development & Entrepreneurship, Government of Nagaland, is designed to govern the operations of private placement agencies (PPAs) offering placement services for private sector jobs within India. The framework ensures that PPAs operate ethically, transparently, and in the best interests of job seekers.

2. Scope and Applicability**2.1 Geographic and Sectoral Scope**

- 2.1.1. The regulation is exclusively applicable to private sector job placements within India.
- 2.1.2. The regulation is mandatory for all private placement agencies operating within the state of Nagaland.

2.2 Registration Requirements

2.2.1. Mandatory Registration with Nagaland: All PPAs must be registered with the Department of Employment, Skill Development & Entrepreneurship, Government of Nagaland. Registrations obtained in other states are not recognized for operations within Nagaland. Therefore, PPA shall also obtain separate registration from the State for operating within the State.

2.2.2. Application Process:

- a) Request for Proposal shall be floated by the Department of Employment, Skill Development & Entrepreneurship, Government of Nagaland for registration of PPAs.
- b) Submission of business registration proof, address proof, background verification of key personnel, details of services offered, past placement reports, and fee structure.
- c) Payment of a non-refundable registration fee as prescribed by the Department.

2.2.3. License Issuance: Upon successful registration, a license valid for 2(two) years will be issued to the PPA.

2.2.4. Renewal: Agencies must renew their licenses by submitting a compliance report and paying the renewal fee.

3. Operational and Ethical Requirements

3.1 Legal and Ethical Compliance

3.1.1. Prohibition of Illegal Placements: PPAs must ensure that none of the candidates are placed in positions involving illegal activities. Any instance of illegal or fraudulent placement will result in immediate cancellation of registration and blacklisting of the agency. This information will be published publicly and communicated to all other State Governments.

3.1.2. Transparent Operations: All job offers must be genuine, with clear and accurate details of the employer including job description, salary, location, and working conditions. Agencies must verify the legitimacy of employers and job offers.

3.2 Advertising and Vacancy Notification

3.2.1. Multiple Advertising Channels: In addition to their methods of advertising vacancies, PPAs must notify the Employment Exchanges in Nagaland about available vacancies. This enables Employment Exchanges to inform registered job seekers about suitable opportunities.

3.2.2. Eligibility of Applicants: Only candidates registered with the Employment Exchange in Nagaland and holding valid registration are eligible to apply for these vacancies.

3.3 Service Fess:

3.3.1. The service charge of PPA from the job seeker, if any, shall not exceed the first monthly wage of the job.

3.4 Post-Placement Reporting and Monitoring

3.4.1. Placement Notification: After successful placement of candidates, PPAs must notify the respective Employment Exchange where the candidate is registered. This helps in maintaining accurate records of placement services facilitated through the Employment Exchanges.

3.4.2. Progress Monitoring: PPAs are required to monitor the progress of placed candidates for a period of 6(six) months. A tracking report must be submitted to the Department of Employment, Skill Development & Entrepreneurship, Government of Nagaland.

4. Compliance and Penalties

4.1 Regular Audits and Inspections

4.1.1. Compliance Audits: The Department will conduct regular inspection and audits of registered PPAs to ensure adherence to the regulatory standards.

4.1.2. Inspection Rights: PPAs must allow Department officials to inspect their premises, review documents pertaining to the candidates and operation.

4.2 Grievance Redressal Mechanism

4.2.1. Establishment of Grievance Mechanism: PPAs must establish a mechanism to address complaints from job seekers promptly. Such grievance shall be brought to the notice of the Department within 24(twenty-four) hours of receiving the complaint.

4.2.2. Complaint Resolution: Complaints should be resolved within 30(thirty) days, and actions taken should be reported to the Department.

4.3 Penalties for Non-Compliance

4.3.1. License Suspension: Temporary suspension of the license for 1(one) to 6(six) months for minor non-compliance.

4.3.2. License Revocation: Permanent revocation of the license and blacklisting for severe violations, such as major violations or exploitation of job seekers.

4.3.3. Blacklisting: Blacklisted agencies will be publicly disclosed, and this information will be sent to all State Governments.

4.3.4. Legal Actions: Initiation of criminal and civil proceedings for fraudulent or exploitative practices.

5. Data Management and Security

5.1 Data Sharing with Employment Exchanges

5.1.1. PPAs must share placement data with Employment Exchanges to ensure accurate tracking and records of job placements.

5.2 Data Security Measures

5.2.1. PPAs must implement proper data security measures to protect the personal information of job seekers.

6. Dispute Resolution Process

6.1 Right to Appeal

6.1.1. PPAs have the right to appeal against penalties within 15(fifteen) days of receiving the penalty notice.

6.1.2. Appeals will be reviewed by an Appeal Review Committee within 30(thirty) days.

7. Amendments and Updates

7.1 Periodic Review

7.1.1 The Department will periodically review and update the regulatory requirements to reflect changes in the private employment landscape and regulatory environment.

7.2 Stakeholder Consultation

7.2.1 Amendments will be made in consultation with relevant stakeholders.

7.2.2 Any recommendation made for amendment to the Regulatory Framework shall be completed within 3 (three) months.

7.3 Notification of Changes

7.3.1. PPAs will be notified of any changes or updates to the regulatory requirements officially and given a reasonable timeline to comply with new or amended requirements.

8. Effective Date

These regulatory requirements are effective from the date of publication of this Notification in the Nagaland Gazette and remain in force until further notice.

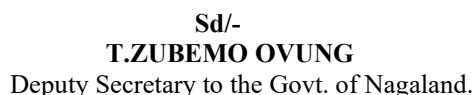
