NOTIFICATION**Dated Kohima, the 8th May, 2025**

NO.NRE/GEN-1/36/2010 :: In exercise of the powers conferred by the proviso to Article-309 of the Constitution, the Governor of Nagaland is pleased to make the following Rules regulating the methods of recruitment and condition of service of the persons appointed to the Nagaland New & Renewable Energy Service:-

1. SHORT TITLE AND COMMENCEMENT:

- (a) These Rules maybe called the Nagaland New & Renewable Energy Service Rules, 2024.
- (b) These rules shall come into force with effect from the date of publication in the Nagaland Gazette.
- (c) These shall apply to the personnel appointed before and after commencement of these rules in the New & Renewable Energy service of the Government of Nagaland.
- (d) These rules may be amended from time to time by the Government.

2. DEFINITIONS

In these Rules, unless there is anything repugnant to the subject or context:-

- (a) "Appointing Authority" means the "Governor of Nagaland" in respect of Group-A and Group-B posts and the Director of New & Renewable Energy in respect of the sub-ordinate post (Non-Gazetted) in the service
- (b) "Commission" means the "Nagaland Public Service Commission"
- (c) "Degree" a degree of University incorporated by an Act of the Central or State Legislature in India, or other Educational Institutions established by an Act of Parliament, or declared to be a deemed University under the UGC Act, 1956
- (d) "Diploma" means diploma from a recognized Polytechnic/ Institute.
- (e) "Committee" means the "Departmental Promotion Committee" constituted under Rules 16 of the Rule.
- (f) "Constitution" means the "Constitution of India"
- (g) "Department" means the "Department of New & Renewable Energy"
- (h) "Government" means the "Government of Nagaland"
- (i) "Governor" means the "Governor of Nagaland"
- (j) "Secretary" means the Addl. Chief Secretary/ Principal Secretary/ Commissioner & Secretary/ Secretary to the Government of Nagaland holding charge of the Department.
- (k) "Gazette" means "Nagaland Gazette"
- (l) "Head of Department" (HoD) shall ordinarily mean the Director of the Department. The Principal Secretary/ Commissioner & Secretary/ Secretary in

charge of the Department of New & Renewable Energy in the Government of Nagaland will be the Administrative Head of the Department (AHD)

- (m) "Member of the service" means a member of the Nagaland New & Renewable Energy Service recruited to the service both Gazetted and Non-Gazetted either before or after the commencement of these Rules.
- (n) "Grade" means "Grade in the service"
- (o) "Schedule" means "Schedule annexed to these Rules"
- (p) "Service" means the employees working under the 'Department of New & Renewable Energy comprising of Group A, Group B, Group C and technical & non-technical sub-ordinate staffs'.
- (q) "Year" means "Calendar year"
- (r) "Examination" means "Competitive Examination for recruitment to the Services" held under Rule 6 of these Rules.
- (s) "Administrative Department" means the Department of New & Renewable Energy under Government of Nagaland.
- (t) "State" means "State of Nagaland"
- (u) "He" shall also mean "She"

3. GRADATION OF SERVICES

The Service shall consist of the classes and categories of posts, the scale of pay and the number of posts as shown in Schedule-I, provided that the Government may from time to time reduce or add to any category of post or posts.

4. CONSTITUTION OF SERVICE

The initial constitution of service, comprising both permanent and temporary posts, shall be as shown in Schedule-I to these rules.

5. METHOD OF RECRUITMENT

- (a) Recruitment of various grades of the service after the commencement of these Rules shall be done through either of the following methods, viz.
 - (i) Direct Recruitment by open competition in accordance with Rule 6(a)
 - (ii) By promotion from lower grade as specified
- (b) The quota allotted to each category of recruitment under (i) and (ii) of Sub-Rule 5 (a) and the minimum educational qualification and other conditions for direct recruitment by competitive examinations/ selection and promotion shall be as mentioned in Schedule-II
- (c) If no suitable/ qualified candidate for the post pertaining to any category of recruitment in Schedule-II arises in a calendar year, the quota pertaining to the category shall be carried over to the next calendar year but, in no case shall the vacancy be carried over to the third year under Rule 5.(a)

6. CATEGORY OF RECRUITMENT.

A. DIRECT RECRUITMENT

Recruitment referred to in Schedule-II shall after the commencement of these Rules be made as follow:

- (i) For the posts which are to be filled up by direct recruitment and which fall within the purview of the Commission, the Head of Department shall send a requisition in duplicate, in the prescribed form to the Commission through the Government. The Commission shall advertise the post(s) specifying the terms and conditions of the rules.
- (ii) A candidate must apply on or before such date in such manner and form as the Commission may prescribe.
- (iii) An examination or interview for the selection to the service shall be held at such time and place as may be prescribed in the advertisement issued by the Commission for this purpose. Every such advertisement shall, as far as possible, specify the number of vacancies to be filled on the results of the examination/interview.
- (iv) For recruitment to the other category of posts other than within the purview of the Commission, the examination/interview shall be arranged in accordance with such rules and syllabus as may be prescribed by the Government from time to time.
- (v) The Commission or the Head of Department as the case may be shall prepare a list of all candidates who have qualified in order of merit, which shall be determined in accordance with the aggregated marks obtained by each candidate and if two or more candidate obtained equal marks in the written or practical examination, the candidate senior in age among this group shall be place above others. The Commission or the Selection Board vide Rule 6.(a).(vii) shall forward the name of successful candidates, in order of merit, up to the number of vacancy/ vacancies reported for direct recruitment to the appointing authority and appointment shall be made in order of names appeared in the list subject to Rule 6.(a).(vi). The list shall remain valid for 6 months from the date the Commission of the Selection Board as the case may be, approves the list.
- (vi) The inclusion of a candidate's name in the list of successful candidates shall confer no right to appointment unless the Government is satisfied after inquiry, as maybe considered necessary, that the candidate is suitable in all respect for appointment.
- (vii) Recruitment to posts outside the purview of the Commission shall be made by a Department Selection Board consisting of the following:
 - (a) Director (N&RE) : Chairman
 - Representative from the Administrative : Member
 - Department not below the rank of Under Secretary

- (b) Representative from the P&AR Department not below the rank of Under Secretary : Member
- (c) An Officer not below the rank of Deputy Director from the Directorate : Member Secretary
- (viii) Provided prior Administrative approval of the Department of New & Renewable Energy is taken before any such recruitment and appointment of successful candidates thereof is done only with the prior approval of the Administrative Head of Department.
- (ix) A waiting list, not exceeding 25% of the vacancies advertised, shall be maintained by the Commission in respect of the examination conducted by them. The waiting list shall remain valid for 6 (six) months from the date the result is declared by the Commission. The name from the waiting list shall be requisitioned by the Government (Concerned Department) only if a candidate recommended by the Commission:-
- (a) Does not join the post after an offer has been made to him or her by the Government or
 - (b) Has been found medically unfit or
 - (c) Has been declared unsuitable for appointment on verification of his character and antecedents or
 - (d) Resigns after joining the post before the expiry of 6 (six) months from the date of declaration of results by the Commission
 - (e) Death of the candidate
- (x) The waiting list shall operate only within the posts advertised by the Commission and the waiting will not be used for filling up an additional vacancy reported by the Government after the last date of receiving application as mentioned in the advertisement issued by the Commission.
- (xi) A waiting list shall be maintained in the same manner specified above ix (a), (b), (c), (d), (e).

7. ELIGIBILITY OF CANDIDATES

The decision of the Commission or the Head of the Department as the case may be, as to the eligibility or otherwise of a candidate for admission/ selection to the examination/ interview shall be final and no candidate to whom a certificate of admission has not been issued by the Commission/ Head of Department shall be admitted to the Examination/ interview by the Commission/ Head of Department as the case may be.

8. DISQUALIFICATION FOR EXAMINATION OR INTERVIEW

Any attempt on the part of a candidate to obtain support for his candidature by any means may be held by the Commission/ Head of Department to disqualify him/her for admission/ selection to the examination/ interview.

9. PENALTY FOR MISCONDUCT

A candidate, who is or has been declared by the Commission or Head of Department as the case may be, guilty of impersonation or of submitting fabricated document(s) which has been tempered with or without making statement(s) which is incorrect or false or suppressing materials, information or of using or attempting to use unfair means in the examination hall/ interview or otherwise resorting to any other irregular or improper means of obtaining admission to the Examination/ interview or of misbehavior in the examination/ interview, in addition to rendering himself liable to criminal prosecution,

- (a) Shall be debarred permanently or for a specified period
 - (i) By the Commission or Head of Department, as the case may be from admission to any examination or appearance at any interview held by the Commission or Head of Department for selection and
 - (ii) By the Government from employment under them
- (b) Be liable to disciplinary action under the appropriate rules, if he/she is already in the service under the Government

10. DISQUALIFICATION FOR APPOINTMENT

- a) No person, who has more than one spouse living, shall be eligible for appointment to any post under these rules.
 - (i) Provided that if a candidate is allowed to marry more than one spouse at a time by any law recognized by the Government.
 - (ii) If the candidate can produce a certificate to these effects signed by a magistrate, not below the rank of Magistrate First Class, he shall not be disqualified by reason of such marriage.
 - (iii) Provided further that any person, after joining the Government service under these rules, marry again when the spouse is still living and divorce or separation has not taken place, the person shall be immediately discharged from the service, unless such person is governed by provision of these rules.
- b) A candidate, who is already in Government service or in the service of the Statutory Body, shall not be appointed unless a release certificate or no objection certificate from the Government or the employer, as the case may be, is furnished.
- c) No person shall be appointed to the service, character and antecedents are adversely reported upon a competent authority.

- d) No person, who attempted to enlist support for his candidature directly or indirectly by any recommendation either written or oral, shall be appointed to the service.

11. QUALIFICATION

A candidate for direct recruitment or Departmental promotion should possess the academic and technical qualification prescribed against each post in Schedule-II.

12. RESERVATION

There shall be reservation for the Backward Tribes of the State as well for the physically handicapped against all categories of posts to be filled through direct recruitment, to the extent and in the manner laid down by the State Government from time to time.

Provided that in the case of reservation for Backward Tribes, if no candidate is available from a particular backward tribe whose turn has come on the roster, the vacancy shall not be filled by a candidate belonging to any other tribes.

Provided further that if no candidate from a particular Backward Tribe is available for filling the vacancy earmarked for the backward tribe in the roster, such vacancy shall be treated as "backlog vacancy" and the process for filling such "backlog vacancy" shall be carried out as under.

- (i) The "backlog vacancy" shall be announced in the subsequent recruitment along with other vacancies (called the "current vacancies")
- (ii) The "current vacancies" shall be treated as one group and the "backlog vacancies" as a separate group.
- (iii) Such "backlog vacancies", earmarked earlier for a particular Backward tribe, shall be carried forward in the ensuing recruitments till the same are ultimately filled up by candidates from that particular Backward tribe only.

13. AGE

- a) The lower and upper age limits for direct recruitment to the service under Rule 6 shall be as per Government Notification No. AR-3/Gen-174/2007 dated Kohima, the 30th November, 2007.
 - (a) Grade-IV : minimum 18 years and maximum 30 years
 - (b) Grade-III : minimum 21 years and maximum 30 years
 - (c) Grade-II : minimum 21 years and maximum 30 years
 - (d) Grade-I : minimum 21 years and maximum 30 years
- b) The Upper age limit for SC/ST candidates will be relaxable by 5 years. But for General candidates, the upper age limit will be 30 years only. Further, age concession for serving Government employee will be allowed, the equal number of years they are in service subject to a maximum of 5 years.

- c) The upper age limit for the physically challenged persons will be relaxable by another 10 years over and above the age ceiling.
- d) The age recorded in the matriculation or equivalent examination shall- ordinarily be accepted as final; and no change/alteration thereof other than already entered in the said certificate shall be accepted.

14. CHARACTER

A candidate for direct recruitment shall produce to the Commission or Head of the Department as the case maybe, certificates of good character from person mentioned below.

- (a) The Principal Academic Officer of the University/College/Institution in which he/she last attended.
- (b) The Gazetted Officers of the either State/Central Govt./Member of Parliament/ Member of Legislative Assembly (who are not related to the candidate) who are well acquired with him/her.

15. PHYSICAL FITNESS

- (a) No candidate recruited direct to the service shall be appointed unless he is declared to be of sound health, both mentally and physically and shall be free from organic defects or bodily infirmity likely to interfere with the efficient performance of duties, who is in all respects physically fit to undertake extensive tour in hill areas.
- (b) A candidate recruited to the service shall be required to undergo medical examination before being appointed to the service by a competent medical broad or by such other Authority as may be decided by the Government from time to time.

16. PROMOTION

- (1) For the purpose of recruitment by promotion against within the purview of the Commission, there shall be a Departmental Promotion Committee consisting of the following Members.

- (a) Provided where promotion is to be made to the post of Head of Department, the Secretary of the Administrative Department shall act as the Member Secretary and the Head of Department shall not be included in the Committee.
- (b) The proceedings of the Committee shall be valid if attended by three members or more members including one each among Sl. No. (1) & (2), Sl. No. (3) & (4) and Sl. No. (5) & (6).
- (c) Where any vacancy/vacancies arise(s) to be filled up by promotion, the Head of the Department shall furnish the following particulars together with his comments, if any, to the Government.
 - (i) Final and undisputed Seniority List of the cadre from which promotion is to be given. The list should contain at least twice as many names as the number of existing vacancies available.
 - (ii) Dossiers of the persons concerned;
 - (iii) Annual Performance Appraisal Reports for the 05 (Five) consecutive preceding years;
 - (iv) Vigilance Clearance;
 - (v) Integrity Certificates;
 - (vi) Service Rules;
 - (vii) List of eligible persons;
 - (viii) Year wise breakup of vacancies;
 - (ix) Order of confirmation in service;
- (d) On receipt of the particulars under sub-rule (c) above, the Government shall furnish such particulars with comments, if any, indicating number of vacancy/ vacancies and other relevant matters as many be necessary, to the Commission.
- (e) If the Commission consider it necessary to make any change(s) in the list received from the Government the Commission shall inform the Govt. of the change (s), proposal and after taking into account the comments, if any, of the Govt. may approved the list finally with such modification, if any, as may be in their opinion, be just and proper.
- (f) The Committee when called upon by the Commission shall meet and prepare a list of officer (s) equal to the number of vacancy/ vacancies in order of preference to be filled in by promotion.
- (g) In every case, where a junior member of the service is selected in preference to his senior in that service, the Committee shall record in writing the reasons thereof for such supersession.
- (h) The select list shall be valid for 1 (one) year from the date of its approval by the Commission. All vacancies arising during the period intended to be

filled by promotion shall be filled up from that list. The selection shall be based on merit-cum-seniority with reference the following aspects of the candidates:-

- (i) Personality and character;
 - (ii) Tact, energy and general intelligence;
 - (iii) Integrity;
 - (iv) Performance;
 - (v) Minimum three years records of service.
- (i) The Committee shall meet once in a year to review the select-list drawn under sub-rule (g). In the event of any great lapse in the conduct of performance of duties on the part of any candidate in the select list, the Committee may, if it so think fit, remove any such candidate from the list.
- (2) For filling up post by promotion to posts outside the purview of the Commission, there shall be a Departmental Promotion Committee consisting of the following:
1. Director (N& RE) : Chairman
 2. Representative from the Administrative Department : Member
not below the rank of Under Secretary
 3. Representative from the P&AR Department not : Member
below the rank of Under Secretary
 4. An officer not below the rank of Deputy Director : Member Secretary
from the Directorate
- (a) The appointing authority shall call upon the Committee to select from amongst the eligible members of the service indicating the number of vacancies to be filled by promotion and shall simultaneously furnish the Committee with the following documents:
- (i) Final and undisputed Seniority List of the grade from which promotion is to be considered;
 - (ii) Dossiers of all eligible candidates;
 - (iii) APARs of all eligible candidates for the last 5 (five) consecutive years;
 - (iv) Integrity Certificate in respect of all eligible candidates;
 - (v) Vigilance Clearance Certificate;
 - (vi) Order of confirmation in service;
 - (vii) Year wise break-up of vacancies;
 - (viii) Service Rules
- (b) The Committee shall examine the character rolls and dossiers of all eligible candidates and prepare a select list contain at least twice as many names as the number of existing vacancy / vacancies available. The selection shall be made on

merit-cum-seniority in all respect with due regard to the following aspects of the candidates viz:

- (i) Personality & Character
 - (ii) Tact, energy and general intelligence
 - (iii) Integrity
 - (iv) Previous record of service for the last 3 years. In every case where, a junior member of the service is selected in preference to his senior in that service, the Committee shall record in writing the reasons thereof for such supersession.
- (c) The Director shall arrange the names of all qualified candidates in order of merit and appointment shall be made in accordance with the list.
- (d) In every case, where a junior member of the service is selected in preference to his senior in that service, the Committee shall record in writing the reasons thereof for such supersession.
- (e) The inclusion of a candidate's name in the list of successful candidate shall confer no legal right to appointment unless the Govt. is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the service.
- (f) The select list drawn shall be valid for 01 (One) year from the date of its approval. All vacancies arising in the grade during the period and intended to be filled by promotion shall be filled up from the list.
- (g) The Committee shall meet once in a year to review the select list drawn. In the event of any great lapse in the conduct of performance of duties on the part of any candidate in the select list, the Committee may if it so think fit, removes any such candidate from the select list.

17. APPOINTMENT TO THE SERVICE.

- (a) The Governor/the respective Appointing Authority shall make all appointment to the service. Appointment to the Gazetted posts in the service shall be notified in the Gazette.
- (b) A person appointed under Rule 5 (i) (a) shall join within 30 (thirty) days from the date of issue of the order of appointment failing which and unless the appointing authority extends the joining period, which shall not exceed 2 (two) months, appointment shall be cancelled.
- (c) Subject to the provision of Rule 6 (a) (v) and Rule 10 (c) appointment under Rule 5 shall be made in order of their name(s) appeared in the list prepared and forwarded by the Commission.

18. PROBATION

- (i) Persons recruited to the service under Rule 5 (a) (i), read with Rule 6 (a), shall be put on probation for a period of 02 (two) years.

Provided that the period of probation in respect of any probationer may, for good and sufficient reasons, be extended by the Government by a period not exceeding 01 (one) year.

- (ii) During the period of probation or extended period thereof, a probationer may be required to undergo such courses of training and to pass such examinations as the competent authority may prescribe in the interest of public service.
- (iii) The period of probation completed successfully shall be counted in full as qualifying service for all purpose.

19. DISCHARGE OF PROBATIONER

- (i) The Appointing Authority may, by serving 01 (one) Month's notice in writing, dispense with the service of a probationer if, during the period of probation or the extended period thereof, the probationer is considered to be unfit for regular appointment in the event-
 - a. He/she fails to make sufficient use of the opportunities given during the training or fails to pass the prescribed examinations or give satisfactory performance during the period of probation or at the end of the probation;
 - b. Information questioning the validity of his/her nationality, age, health, educational qualifications, integrity, character and antecedents, is received by the Appointing Authority and the Appointing Authority is satisfied that the probationer is ineligible or unfit to be a member of the service, after due inquiry had proved the allegations to be true; or
 - c. He/she fails to abide by any of the provisions of these rules
- (ii) The probationer shall not be entitled to any compensation in the events of service being dispensed with under sub-rule (i) above.

20. CONFIRMATION

- (i) When a person on probation completes the period of probation successfully to the satisfaction of the Appointing Authority, such a person shall be eligible for confirmation, provided he/she is considered fit for the confirmation of all other aspects and condition as may be prescribed by the Government from time to time.

- (ii) Confirmation in service will be done only once in the service of an employee, i.e., in the entry grade of the cadre.

NOTE: Successful completion of training includes passing of any Departmental examination, test or training if any.

21. SENIORITY

- a) Seniority of persons appointed through direct recruitment shall be fixed in accordance with the merit-list published by the Commission or Selection Board. Provided that if a person do not join the service within 30 (thirty) days from the date of issue of the offer of appointment or within the period specified or within the period of extension of joining time offered, he/she shall rank below those who had joined earlier.
- b) Seniority of persons on promotions shall be determined by the order of their selection as recommended by the Departmental Promotion Committee.
- c) The inter-se seniority of promotes and direct-recruits in a grade, where percentage of vacancies reserved for each source is 50% and appointment to which is effected in a calendar year, shall be in the order as under;

22. TRAINING / DEPARTMENTAL EXAMINATION

The Government may prescribe, from time to time, course/training/examination etc. to be passed by the various categories of employees of the service. Unless the members of the service passed/successfully completed such course/training/examination, they will not be considered for confirmation/promotion to the next grade.

23. INTERPRETATION

If any question arises relating to the interpretation of these rules, it shall be referred to the Government in the Department concerned whose decision thereon shall be final.

24. REPEALS AND SAVINGS

All rules corresponding to this rule as might be in force immediately before their commencement and hereby repealed in respect of matters covered by these rules. Provided that any order made under rules so repealed shall be deemed to have been made or taken under the corresponding provision of these rules.

25. POWER TO RELAX RULES

Where undue hardship is likely to be caused to any person by the application of any of these Rules, the Governor shall have the power to relax the application of that Rules in

respect of that person for good and sufficient reason, which shall be without prejudice to the interest of any other member of the service.

26. REVIEW OF SERVICE

An official's service, on attaining the age of 50 (fifty) years or 55 (fifty five) years shall be reviewed as provided under Fundamental Rule 56 (J).

27. MISCELLANEOUS

Except as provided in this rule, all matters relating to pay. Allowances, leave, pension, discipline, conduct and other conditions of service shall be regulated by general rules on those behalf framed under Article 372 of the Constitution of India.

2. For **SI No.I**, the District Administration and Police of Dimapur, Chumoukedima and Niuland and for **SI No.II**, the District Administration and Police of Kohima, Dimapur, Chumoukedima, Niuland, Wokha, Mon, Longleng, Peren and Mokokchung to identify and set up points for issue of Permit/Pass on Physical & Online mode.

3. The District Administration through the Office of the Commissioner Nagaland, to ensure that 33 % of the ILP fees levied on each category of ILP to be remitted to the concerned Village Council as per the Register of ILP Holder staying in the Village which are maintained by the respective Village Council.

The concerned Village Council will report to the District Administration on the list of ILP Holders under their respective Village on a monthly basis.

4. Sensitisation exercise of the Police Personnels and other security implementing agencies on the issue of ILP and its various categories. The DCs & SPs of the respective District to immediately call meeting with Civil Societies Organisations and Tribal Bodies. Police Personnels and DBs on the ground should be thoroughly briefed that there is no unnecessary harassment.
5. All House Owners renting out premises to persons other than Indigenous Inhabitant and PRC holders must certify and submit details of their tenants to the competent authority i.e. Village Council/Police in physical or digital mode as the case may be. Failure to report will attract penalties under applicable laws.
6. Hotels, Guest House, Resorts, Homestays etc to inform the nearest Police Stations mandatorily on arrival of the tenants/guests from other State. The Police Station to have dedicated Whats App Number/ App for this purpose and to circulate widely.
7. Checking of ILP shall be done by Authorized Govt. agencies only. Any Civilian or Civil Society Organisations imposing any fines/penalties on individuals in violations of ILP regulations shall be liable for punishment.

8. Earlier provision issued as per this Office Notification NO.CON-3/PAP/65/10 Dated: 20/09/2024 and No:HOME/LP-36/01/2024/200 Dated: 18/06/2025 will continue i.e.

- i. Those ILP Applicants coming from the State of Assam i.e. Karimganj, Hailikandi, Dima Hasao and Karbi Anglong will be required to produce National Register of Citizen (NRC) in addition to the documents cited above.
- ii. The ID Card of the concerned employee is enough for the family and dependents of the Central/State Government agencies in lieu of ILP.
- iii. Heads of Public or Private companies duly registered can stand as Guarantor for their regular employees.
- iv. Employers can certify and act as Guarantor provided that the Employer Certification should be supported by NOC from the Landlord/House Owner.
- v. Transit passengers are exempted from producing ILP.

9. The provisions of this Notification are subject to revision by the State Government as and when required.
