No.GAB-I/COM/CAWD/184/2015/360: In the interest of public service, the Governor of Nagaland is pleased to accord sanction for creation of 26 (Twenty Six) temporary posts as per details indicated at **Annexure-I** under the establishment of Assistant Chief Engineer (CAWD), Nagaland for regularization and absorption of 26 (Twenty) various categories of Work-Charged and Casual employees as per the Scheme for Regularization and absorption of Work-Charged and Casual Employees and Revision of Pay/Wages vide P & AR Department's O.M No. AR-3/GEN-201/2009, dated 17.03.2015 under the following conditions:

1. This is a Non-Plan Expenditure.

Method of fixation of pay upon personal upgradation/upgradation.

1. It has been observed that upon personal upgradation/upgradation of a post the benefit of pay fixation under FR 22 (1) (a) (1) is not extended to a Government servant to fix his/her pay in the next higher grade thereby resulting in instances where upon upgradation an employee is fixed at a lower pay than he/she would have drawn in the lower grade.
