**NO.LAB-1/1/2024-25(Vol)/922 :** In pursuance of the State Government's commitment towards Ease of Doing Business (EoDB) reforms, digital governance and service delivery efficiency, and in exercise of the powers conferred under Section 34 of the *Nagaland Shops & Establishments Act, 1986*, read with the *Nagaland Shops & Establishment Rules, 2015*, and the executive powers of the State Government under the *Factories Act, 1948* pending framing of State Rules, the Government of Nagaland hereby notifies as follows:

**1. Introduction of Online System for Registration and Licensing:**

With effect from the date of notification, all processes relating to registration, approval, licensing and renewal under the following Acts shall be carried out through the official online system available at <https://labour.nagaland.gov.in>:

- (i). Factories Act, 1948 (Interim phase)
- (ii). Shops & Establishments Act, 1986 (Mandatory from date of issue)

**2. Mode of Submission & Issuance:**

- (a) Applications, supporting documents and fee payments shall be made online.
- (b) Certificates and licenses shall be issued electronically.
- (c) Digitally issued certificates shall be treated as legally valid for all official and inspection purposes.
- (d) No physical/manual applications shall be accepted, except in exceptional cases with written approval of the competent authority.

**3. Interim Operational Framework:**

Pending the framing and notification of the Nagaland Factories Rules under the Factories Act, 1948, the above online system shall operate as an interim facilitation mechanism for factory-related applications.

Applicants may submit applications, documents and fee payments through the online system. Digital acknowledgements and licenses shall be issued through the system.

**4. Pilot Implementation:**

The online system shall first be implemented in the districts of Peren, Phek, Longleng and Kiphire for a period of three (3) months from the date of this notification.

**5. State Wide Rollout:**

Statewide roll-out shall be undertaken based on successful evaluation of the pilot phase or upon completion of three (3) months, whichever is earlier.

**6. Awareness & Support:**

The Department shall conduct training, awareness and help-desk support for stakeholders to facilitate smooth adoption of the online system.

**7. Without Prejudice to Rule-Making Powers:**

This Notification shall operate without prejudice to the State Government's rule-making powers under the respective Acts and shall not be construed as amending any statutory provision. It shall remain in force until formal Rules or further orders are issued.

1. African Swine Fever (ASF).
2. New Emergent Diseases.

The guidelines & parameters of the diseases to be declared as State Specific Disaster is **Annexed.**

The affected farmers and communities by the notified acute epidemic state local disaster and concerned authorities involved in the process of administering the relief as per the norms of assistance must strictly follow the guidelines and parameters as indicated.

ANNEXURE**Guidelines & Parameters of the diseases to be declared as State Specific Disaster in respect of A.H & Veterinary Services, Nagaland.****1) African Swine Fever (ASF)**

1. India has not developed any vaccine for control of ASF for which its outbreak cannot be contained causing great economic losses to the farmers in the State with mortality rate as high as 100%.
2. When there is suspected outbreak of ASF, the respective Chief Veterinary Officers (CVOs) has to take the responsibility for collection of sample from the source and submit to ELISA Lab, Kohima which will be sent for Laboratory test for confirmation at North Eastern Regional Disease Diagnostic Laboratory (NERDDL), Khanapara, Guwahati.
3. **Protocol for Notification:** Once the disease is confirmed, it will be intimated to the respective CVOs who will write to the District Administration for Notification of the disease outbreak and initiation of National Action Plan (NAP).
4. **Protocol for culling of animals:** When the outbreak is confirmed, from epicentre to 1 kilometre radius to be declared as Infected Zone. All pigs are to be culled within the Infected Zone following all standard protocols to prevent the disease from spreading further. This also includes the destruction of feed, beddings, waste materials, etc. in the area.
5. **Surveillance Zone:** From 1 km to 10 km (9km) radius to be declared as Surveillance Zone.
6. Strict restrictions on the movement of live pigs and pork products both into and out of Infected Zones. Restriction to remain in place for a minimum of 6 months before re-stocking/re-population for ASF-infected premises.
7. The respective CVOs are to submit the culled and death reports to the District Administration along with owner's details, evidences and other necessary protocols to be followed to claim for relief under the State Disaster Response Fund (SDRF).

**2) New Emergent Diseases**

Any new emergent diseases of unknown causative agent affecting mass population of livestock causing severe economic losses to the farmers may be considered to be eligible for relief under the State Disaster Response Fund (SDRF). In such occurrences the containment measure may be the same as other notifiable diseases.

Whereas, it is observed from vehicle data available on the VAHAN Application that vehicle owners are not coming forward for reporting such matters to get the certificate of registration cancelled; and,

Whereas, this inaction on the part of the vehicle owners is leading to a lot complications and misrepresentations of data such as:

- a. Arrears in collection of tax or tax default;
- b. Non compliance to provisions of the MV Act and Rules like plying of unregistered/non-renewed vehicles;
- c. Plying of unfit vehicles like non compliance to fitness test, pollution tests, insurance failure, HSRP not fitted etc.

Now therefore, in exercise of the powers conferred under sub section of (3) of section 55 of the Motor Vehicles Act, 1988, all vehicle owners who have not renewed their certificate of registration for 5 years or more, are hereby given 30 days time from the date of issue of this Office Memorandum for getting the Certificate of registration of their vehicles renewed or get the Certificate of Registration cancelled at the respective registering offices, failing which, the Registering Authorities shall process for cancellation as stipulated under section 55(3) of the Act, presuming that the vehicle is incapable of being used or its use in public places would constitute danger to the public and that it is beyond reasonable repair.
